**Preface**

**The Definition of Culture**

Culture has been defined in many different ways by cultural experts and scholars. The Encyclopaedia Britannica has so far [\(1\)](#) cited ۱۶۴ various definitions of culture. By studying these definitions carefully, it may be concluded that some of them intend to identify certain cultural elements, e.g. scientific culture, artistic culture, literary culture and moral culture, all of which serve only to describe various aspects of the cultural phenomenon such as art. Some definitions refer to pursuant culture, and some others depict pioneer culture, although they do not directly do so.

Let us consider a simple example to elaborate on the fact that all the existing

definitions fail to put forth a thorough explanation of culture. Suppose a number of people are trying to find the centre of a circle by considering many points in it. Clearly, none of them would prove to be the real centre; thus, cultural scholars and sociologists have not taken into serious consideration the true identity of man, which lies in the boundary

Instead, they have merely studied some of the cultural elements, especially physical phenomena and cultural activities. Therefore, it is obvious that the number of physical outcomes could lead to countless definitions, much higher than ۱۶۴. In proof of this, notice the neglect toward the innate virtues of culture, the aspect of virtual beauty to name one. On the contrary, culture consists of two parts: internally virtual and externally virtual. The most complete definition that can be derived from most of the present ones is

Culture is the necessary or proper quality in man's physical mental activities, based“  
(on sound logic and emotions rising from sensible evolutionary lifestyles. (۱)

The elements and examples presented in the current encyclopaedias and lexicons refer to qualities of both necessity and appropriateness. In other words, they consist of proper facts and also necessities for human life. French Encyclopaedias state that

Culture consists of all the knowledge acquired by man or society, such as a set of activities based on various socio-historical rules, or structures caused by changes in behaviour or deeds due to specific educational conditions

The sentences above include both, the absolute vital and also the unnecessary but  
,proper conditions of life. However

Of course, the above definition only applies to pioneer societies, whereas pursuant –۱  
.culture does not focus on progress or evolution

as we will see further on, the necessities and proper conditions do not totally exclude  
man's personal needs. Some experts believe that culture consists not only of the  
essentials of life, such as natural sciences or humanities, but only the suitable aspects  
worthy of forming the basis of a culture. Here we must keep in mind two important  
.principles

One: The more distance between culture and natural life and fatalistic facts, and also  
.the more evolutionary virtual facts it includes, the more human it will be

Two: The highly elevated spiritual value according to which man constantly wishes to  
.fill every aspect and action of his life with excellent virtues

On the basis of these two rules, some idealistic and pioneering anthropologists  
believe that culture has always played a major role in the evolutionary progress of  
.mankind

### **Concern about the Future of Evolutionary Culture**

If a day comes when humans begin to lose the desire to reach harmony in dignified  
freedom, unconscious fatalism will put them in a mechanical life ignorant of the truth,  
and call it human unity. If someday the plague of deculturization infiltrates humans so  
strongly that it even ruins the common virtues of evolutionary cultures in various  
.nations, it would unquestionably reveal the shameful incompetence of their leaders

Despite centuries of evolutionary endeavour by holy prophets men of wisdom,  
moralists, and the sacrifices of those martyred for the sake of freedom and human  
dignity, social leaders today have not only proved themselves unable of uniting

based on evolutionary cultural virtues, but have also lowered man to ignorant  
.components of a machine

They have deprived man of the glorious life he deserves, and restricted him to only  
the physical desires of life, such as greed for power, dominance and selfishness. On  
that terrible day, which might not be so distant, history's sensitive conscience and  
God, who provided men with conscience to guide them through time, will take  
.revenge on those who have demolished human dignity and values

All authentic human cultures, holy prophets, distinguished anthropologists, moralists  
and those who have contributed to the culture of man's history clearly show that the  
only way to establish harmony and dignity among mankind is definitely through  
elevated virtues and morals, not mechanical characteristics and qualities. The reason  
is that the more man deviates from highly moral virtues, the more influenced he will  
be by his natural animal self. Animals also possess this kind of self –although in a more  
limited form –whereas in humans it handles the essence of man, for human capacities  
.are so many and mighty that they mutually infect the universe and their peers

The natural self knows no sympathy, emotions or logic. It totally ignores conscience,  
evolution and culture. However, unless these great human virtues are achieved,  
human unity and brotherhood would be merely a dream, for selfishness and greed for  
personal desires are a natural part of the animal self, which has led to the countless  
.wars and atrocities in the history of man

Islamic culture has thus shown great concern for the future of modern societies. Yet,  
some Western scholars have not only foreseen the demise of Western culture, but  
also believe it to be happening at the moment. Albert Schweitzer thus describes the  
:critical state Western culture is in

It is obvious to everyone that we are heading for cultural self-destruction. What is left for us today is by no means safe, for it has not come under destructive pressure yet, and is surely too frail to be able to resist it. Modern man has much less capacity for culture nowadays, because his environment has damagingly degraded his [\(spirit.”](#)

Schweitzer believes that industrialized man is devoid of freedom, unable to focus his :thoughts, incomplete, and in danger of losing his human self. He further adds

Society has developed so sophisticatedly that it can secretly control men, and has made him so dependent on his society that he gives up his entire aspect of thinking and reasoning... therefore, we have entered a new era of medieval times. Thought has deliberately been abandoned in the name of freedom and men are controlled by their societies. We have inevitably lost faith in the truth because we have sacrificed our mental independence. We have disturbed our own mental-emotional balance.

[\(Inadvertent attention in any aspect can lead to thoughtless establishment.](#)

Schweitzer considers “inadvertent struggles” another characteristic of industrial societies. During the last few centuries, men have been working like machines, not human beings. The essence of humanity

has been contaminated, and never generations lack the necessary factors for human :evolution

Adults are drowned in work, increasingly submitting to superficial disturbance“ absolute passiveness; ignoring their own “ego” and deviation has become their [\(physical need.”](#)

In his conclusion, Schweitzer emphasizes that man should reduce the pressure of his

Schweitzer; a Protestant, agreed with the Dominican Reverend Eckhart that

Man should not submit himself to the spiritual isolation considered 'selfishness; he“ should actively contribute to developing his society to the highest possible level of morals. If nowadays only few people still possess human emotions, it is because they tend to sacrifice their piety and moral values for their own native land –they never exchange cultural values with other societies that could guide them toward high [\(spiritual development.\)](#)

Schweitzer then concludes that the current social and cultural foundations are leading us to a disaster that precedes a second Renaissance even greater than the original– unless we wish to self–destruct

During the second Renaissance, mentally originated activities will prove crucial; in“ fact, mental activities have been the only logical and practical principal man has come up with in his historical evolution ...I have no doubt that if we act thoughtfully, the [\(revolution will take place.\)](#)

However, the second revolution may be, its basis will definitely be moderate selfishness, greed for power and pleasure, for without religious influence, the revolution would be impossible. It is quite likely that it be a religious revolution, which Islam –especially the Shiites –have

.been a waiting, in order to form a divine global society

It is a certain fact claimed by scholars of the humanities and positive philosophies that in our era, crucial changes are on the horizon. Whatever kind of evolution it may be, it

will certainly concern human beings. In assessment of the coming dramatic evolution,  
:two major theories have arisen

The First Theory: pessimistically believes that human beings are heading for spiritual and moral breakdown. Even if humans are not totally demolished, they will become selfish, greedy living beings lacking logic and conscience, drowning in their desires,  
.and have no choice but to fit in the machine like nuts and bolts

The Second Theory: an optimistic one, states, “The evolution will once again revive original values by considering man's intrinsic capacities for evolution, and thus regain  
”.him his true self

Evidence shows the latter to be preferable, provided cooperation –and if necessary, even sacrifice on behalf of the leaders of the society alongside men of true wisdom and authentic scholars of culture and humanities. But if, Heaven forbid, the selfish and power-greedy keep on injuring humanity, and neglect the suicidal fall that awaits all of us, the underlying evolution will definitely follow the first, pessimistic theory –if, of course, it does not lead to the annihilation of the world and its dwellers. According to  
.that theory, humans will be degraded as worthless as gears in a machine

Considering man's intrinsic need for seeking excellent values and his long-established  
passion for

evolutionary culture, and having in mind God's unquestionably wise will, we support the second theory, and predict a prosperous and encouraging future after man undergoes a great deal of suffering. Among the primary reasons for our logical optimism is the fact that man possesses the virtual desire for excellent evolutionary culture, and is always eager to protect himself from various events that threaten  
.mankind

### **The Importance of Research on Definitions of Culture**

In this section, after examining comprehensive definitions of culture in various

peoples and nationalities, we will come to the undeniable conclusion that since mankind essentially desires culture; he will prevail amidst all forces, greed and sensuality. As the glorious Koran says

God sends down out of heaven water, and the watercourses flow each in its“ measure, and the torrent carries a swelling scum; and out of that over which they kindle fire, being desirous of ornament or ware, out of that rises a scum like it. So God strikes both the true and the false. As for the scum, it vanishes as jetsam, and profits [\(1\)](#) men abiding in the earth. Even so God strikes his examples.

The main reason for studying the supplied definitions of culture in the best-known encyclopaedias and some lexical and sociological references is to prove whether all societies of mankind believe that the true meaning of culture includes the proper, deserving human evolution or not, and that even if the selfish, greedy or nihilists attempt to degrade it to a paradise of banal phenomena which they call culture, it would still be false and antihuman

It is the variety in scholars' points of view in interpreting culture that has brought about a myriad of definitions, whereas they are all in agreement about the main core of culture. As we will see later on, some of the current differences are due to time and some popular phenomena, and some others are caused by environmental features and various perceptions of ideologies. For example, farhang, the

equivalent in Farsi for culture, means to pull (1); it also refers to a branch bent down and covered with soil to help it grow, and able to be planted elsewhere

The Arabic equivalent for culture, al-thiqafa, means triumph, intelligence and skill, and (also means talent for science, crafts and life nature. (2)

In French, culture has derived from the Latin word cultural, which means cultivating (the earth for agriculture; in also means planting. (3)

In the German language, it conveys raising bacteria and other living matter on a background of prepared food; cultivating and protecting farms; and also a new group (of organic living matter. (4)

And finally, in Russian it means determining the extent of man's influence on nature and his achievements in doing so

### **Interrelations among Definitions of Culture**

Taking the various concepts of culture throughout history into consideration, we can form a comprehensive definition: a general concept conveying victory, cunning and

understanding in Arabic; planting and farming in Persian; and cultivating the soil and  
.agriculture in Latin

However, our studies do not intend to prove that culture shares the same etymology  
in all lexicons and encyclopaedias around the world. But we are confident that the  
word culture and its synonyms in the lexicons of nations of ancient civilizations, all  
generally convey planting, capability of agriculture and organic life heading toward all  
.features of fine intelligent and artistic life

### **In Search of the Comprehensive Valuable Truth called Culture**

Let us presume the term conveying fine valuable culture in different ethnic groups  
and nations throughout history –that undergoes virtual changes and has recently  
found entirely new

meanings –is culture, which in ancient Persian means laying down a branch in order to  
raise it as a shrub, and has gradually changed to convey wisdom, education, and  
great intelligence. Let us also presume that the word “culture” has been used in its  
filthiest ways. However, changes in a word's meaning cannot demolish the concrete  
.truth in logical life

For example, consider the Persian word “qanoon”, which means a musical instrument.  
Years later it was used to convey the truth, or an important lifetime spent interpreting  
the truth. If we suppose that in some societies, tyrants use such words as they desire  
regardless of the true meanings they have, should we come to the conclusion that  
qanoon has lost its fixed meaning which refers to the relationship between man and  
his own self, God, the universe, or his fellow men? It would definitely be wrong, for the

events depicting the relationship between man, God and other beings are unquestionably unchangeable, even if they are not termed qanoon

In the next chapters, we will strive to find the fixed comprehensive truth which, whatever called, never loses its crucial role to man –unless man gives up his identity in his world of machines to such an extent that his life, soul and true self are totally demolished; or as Tyler has said, “evolve into an intelligent ape [\(۱\)](#) and eventually become a part in the machinery

culture in one single volume. However, we can refer to distinguished dictionaries and encyclopaedias and explore the main ones given by established scholars around the world.

### Culture Described in Persian Reference Books

Farhang (derived from farhandge), (the Farsi equivalent for culture) refers to “knowledge, intelligence, wisdom, accountability, a Persian lexicon, Keikavus’ mother, [\(۱\)](#) and a branch put in soil to be planted elsewhere. It also means a water drain.”

Hossein ibn Fakhruddin Hassan Anjui Shirazi believes “farhang to have six various meanings

Explaining the entry “farhang” in his Persian encyclopaedia, the late Dekhoda has cited many verses by distinguished literary figures in Persian in order to further illustrate the vast range and depth of culture in Persian literature

The Persian Encyclopaedia reads: “Culture shows a peoples' life style and traditions in anthropology. Its English equivalent was first used academically in the nineteenth century by Sir E.B. Tyler. The concept of culture has proved so useful that it is now also used in other fields of sociology, literature and biology. Culture has been the

.distinctive point between mankind and animals ever since the rising of man

The traditions, ideas and conditions of a group are passed on through its generations mostly by education, not genetically. Following customs is enforced in each culture through its own special system of rewarding and punishment. Language and other symbolic tools do play an important role in the transfer of culture between generations, but some kinds of behaviour can be achieved solely by experience. Every society possesses its own specific “cultural basics” which include all organizations necessary to man, e.g. social organizations, religion, political organizations, economic organizations, and material culture (tools, devices, weapons, clothing, etc.). Sophisticated societies are distinguished from “primitive” ones in the complexity of .their cultural bases. However, these two terms must always be considered relatively

Basically, each human community has a definite culture, but in complex societies, secondary cultures can also branch

out of its national, social and religious conditions. On the other hand, peaceful or even hostile cultural contact can lead to common cultures acceptable by various nations – based on the fact that co-culturalism can exist and each side may adopt the other's traditions. The characteristics of a culture may be spread directly or indirectly among .its groups. Such a process is called diffusion

A cultural area is a land where some features of a culture are visible. Various schools of thought have emerged in anthropology attempting to account for how cultures work, develop and spread, but all agree on a vast evolutionary process throughout the history of man, especially in technical and economic domains. However, the evolution has not taken place at the same rate for all nations, and is still incomplete in .many of them, although at times co-culturalism can integrate several steps into one

In the first phase, food-hunting, small groups of nomadic hunters, fishermen and fruit

pickers move from one place to another in search of food. They live temporarily in caves or other shelters, as in the lower and middle Stone Age

The next phase is producing food, in which man has learned how to tame animals and use plants. He lives in small settlements, like the upper Stone Age

.After that, civil life began, evidence of which can be found in great ancient civilizations

Categorizing a contemporary culture should not be done solely on the basis of its technical or industrial progress. For example, today's

food-hunters, e.g. native Australians are not comparable with lower Stone Age hunters ۲۵,۰۰۰ years ago, because ancient systems of relationships and religion must (have been different.”(۱

No dictionary or encyclopaedia has provided a clear-cut, specific definition of .۱ culture. The reason is not negligence on behalf of scholars in identifying culture, but due to the great diversity in cultural elements and phenomena, which prevent a fixed comprehensive definition. Neglect in achieving a complete definition could also be due to some cultural researchers ignoring its spiritual and supernatural meanings –an .ignorance which has unfortunately infected some people

(Culture has been the point of distinction between man and other animal species.”(۲“ .۲

If we are to take into account meritorious deeds and phenomena in our definition of culture, we would have to search for the distinctions between man and animals before the existence of culture in man's fatalistic life, for some scholars consider meritorious phenomena and deeds prior to his compulsory affairs in life, e.g. thinking about preparing a settlement, developing legal relationships among a society, social .management, etc

In all, all anthropologists approve of a step-by-step evolutionary process in the“ .۳

[\(history of mankind, particularly in technical and economic areas.”](#)[\(۲](#)

This is an absolutely correct fact, also applicable to scientific and technological progress made by civilizations; in other words, no theory or school of thought is able .to prove these events advancing in a direct, orderly fashion

Anyone aware of the development of science and civilizations admits that the factors .causing their existence have not only been irregular, but totally unpredictable

c. “Sometimes co-culturalism can integrate a few of the phases in the process. In the first step, food seeking, small groups of nomadic hunters, fishermen and fruit pickers [\(move form one place to another in search of food.”](#)[\(۲](#)

Here we can see phenomena concerning culture and its mutation –which, however, due to their fatalistic nature – cannot be included in the evolutionary concept of .culture

The Arabic equivalent for culture is the word al-thiqafa which means “victory, intelligence and skill, and also talent for science, crafts and literature.”<sup>٢</sup>

“Its root, thaqaf, means skilful, clever, brilliant and victorious.”<sup>٣</sup>

To find a definition of culture and the topics concerning it, it is best to look up al-thiqafa and al-adab.<sup>٤</sup>

Al-Monjad thus defines al-adab: “An adib is a person familiar with literature. Its plural form is oda'ba. An adib is well-trained in

lexical and literary subjects, and possesses great culture. Adab means science and knowledge as a whole or a particular field. It also means what a person or object morally deserves, e.g. how one should behave in a classroom, or as a judge, etc.<sup>١</sup>

In the following verses also, adab refers to culture, and conveys knowledge and demonstration of fine morals according to appropriate principles achieved through conditions in one's lifetime

Two points should be considered about the definition of culture in French reference books

A careful study of the above definitions shows that the majority of the meanings provided are based on virtual facts which remain unchanged even if the objects or persons applicable to them do, unless the whole nature of mankind undergoes complete metamorphosis and becomes a helpless thing like animals or objects or parts of machinery. However, literary and philosophical culture will be unaffected, for their bases are truly unchangeable

It is impossible to change the truly original facts shown to the French by Victor Hugo in *Les Misérables*. Even Sartre and his like, with all their novel phrases and terms tending to influence the simple-minded, failed to eliminate Victor Hugo's *Les Misérables* from the culture

of mankind. Likewise, the dogmatic writers of our own era could not eliminate the role of Mowlavi's *Mathnavi* in great human culture; all they achieved was brainwashing the simple-minded with their contradicting jargon

They felt that they were fulfilling their own selfishness, which was a grave mistake itself; selfishness is an insatiable flame that only quenches when it has burned itself out, no matter how many others it also victimizes in the process

Categorizing the meaning of culture into the real and the figurative leads to three .2

possibilities: first, some meanings may be archaic, e.g. agriculture and cultivation of the soil, which is the Latin meaning for culture. Some other meanings are frequently used regardless of their older ones. The second possibility is that culture initially meant agriculture, but through gradual use in texts of high moral values, was transformed to a new meaning. Third, the old meaning of culture, i.e. cultivating and using a potential, is an unchangeably comprehensive reality applicable to various things, e.g. the soil, trees, animals and human beings

Therefore, metaphor interpretations in this case cannot have a definite, evidential reason. We also must keep in mind that if a word changes in meaning, its original meaning, conveying definite true fact(s) is not necessarily omitted

c) Efforts have been made ever since mankind inhabited the earth and culture arose with them towards providing human character with originality, finesse and form, .limiting inferior human desires and transforming them into highly elevated needs

The first significant point about the above definition is that such encyclopaedias, having mentioned the highest facts of value defining culture –such as giving form, originality and delicacy to man's character and transforming his mediocre desires into high moral needs –state that “culture began when mankind arose on earth.” In other words, the facts described as meaning(s) of culture are unchangeable, and cannot be contaminated by the new worthless meanings added to culture nowadays, ”.considering “what man's talents show” and “what his values represent

### **Culture in the Encyclopaedia Americana**

Culture, a vast concept, has been used by sociological and anthropological experts.“ Its other meanings refer to educated persons, i.e. those who are well–composed and .are familiar with culture and the fine arts of life

Specialized discussions on culture arose in anthropological texts of the mid–nineteenth century. Sir Edward Burnett Tyler, the English anthropologist, used the term “culture” to represent a developed series of ideas and what arises out of historical experiences. In 1910, American anthropologists used

culture to show the specific characteristics of peoples in societies. In the 1930s, Ruth Benedict described culture as those patterns of thought and action that makes one .distinct among others

The word “culture” is of much significance to sociological experts, for it provides the simplest concept for expressing the behaviour and history of mankind. For instance, compared to the term “society” –which, by definition, refers to an organized group dependent upon each, other who coexists inside a system in order to continue their production and life –culture has vaster applications. Culture shows the behavioural content of the society. The point here is: Why has culture found so many various

The reason is that culture does not consist of a single, homogeneous topic or refer to an individual. It covers many elements, including ideas, emotions, values, ends, behaviours, tendencies and experiences

### **The Evolution of Culture**

Studying the process of evolution in the history of culture, we come to three significant points: first, culture can form the distinction between human characteristics and animal norms. Secondly, the observed behavioural pattern is due to the outcomes of man's cause-and-effect physical development. Thirdly, population growth and the cultivation of man's surroundings have led to cultural manners focusing on symbols and language, in turn resulting in a vast treasure of thoughts and ideas throughout history. Considering it through a vaster point of view, we may realize that culture is not the fulfilment of one of man's needs, but a manner-based phenomenon aiming to provide magnificent virtues of life to

The economic and materialistic aspects of man's life have, in various stages, become his ability to transform his natural surroundings into higher comfort and more property. Although the artistic, research and philosophical aspects of culture have also developed, we are not sure if they have done so in certain stages

All in all, absolute diversity in cultures on earth seems to be fading away. The increase in Western, industrialized lifestyles spreading around the world has influenced many unique distinctions at the cost of replacing them with industrial civil patterns

Historians and anthropologists believe that cultural diversity must have reached its peak during the 14th and 15th centuries; i.e. before Europeans began to infiltrate into the lifestyles of other nations

### **Cultural Elements**

Analyzing cultures requires certain concepts. First, we can categorize cultural elements

according to quantity and basic principles. However, using specific terms will lead to the same series and usages. Apart from classifying the constituents of culture, other concepts are also necessary for research and utilization of culture. Here, we are faced with two significant ideas: concepts and actions

Each cultural element (showing ideas on behavioural patterns, or objectives) includes all interpretations or symbols of the mental reactions of those facing the element

The usage of a cultural element is determined by its researcher, not an individual caused by the culture. Sociologists have also categorized culture into two schools of thought which are to fulfil man's mental needs

### **Cultural Manner**

Pattern-based manners can also be defined in culture using a specific method; in other words, culture can be used to define the way to do certain things in society

Therefore, “cultural subgroups” convey certain methods for some of the actions in specific parts of the society. Thus, Afro-Americans in the United States have lifestyles very different from others, although they all live in one country. Culture used in behavioural manners is mostly applied to solve problems

:There are several points to consider here

Its (culture's) secondary concepts symbolize educated, well-cultured people.” It is“ .1 incorrect to call this a secondary concept, for any individual who possesses the virtual characteristics called culture can be considered a cultural person, as we would regard anyone that has the qualities and manners of civilization civilized. The concept and ,term “civilization” is not a sideline concept for civilized man

The text, unfortunately, does not mention the time-honoured originality of cultural .۲ phenomena such as science, education, moral virtues, and art

Since cultural elements and activities concern the appropriate values of man’s life, we must point out that the intrinsic culture-seeking potentials in humans are virtual, and activating them calls for need and conscious effort. For example, the potential need for acquiring science, art and moral virtues exists in humans regardless of time or geographical issues, but using it in reality requires education and practical .admittance

A considerable point in the Encyclopaedia Americana is, “The term 'culture' is of high .۴ importance to sociologists, for it provides the simplest concepts needed to express human behaviour and history. For instance, compared to the term “society” –which, by definition, refers to an organized group dependant upon each other coexisting inside

a system in order to continue their production in life –culture has vaster applications.

”Culture shows the behavioural content of the society

It is true that culture is highly important, but we must note that its importance is not due to the fact that it provides the simplest concept expressing the history and behaviour of mankind, for the simplicity of a mass abstract noun, such as law, pleasure, sorrow, generosity or reality cannot possibly lead to its comprehensive explanation. Therefore, encyclopaedias

and dictionaries have begun research to find the complete truth about culture –and have so far led to around ۱۶۴ definitions of it–likewise; much effort has been put into [\(research on the concept of law.\)](#)

This is the best reason for the complexity in the definitions of culture. The fact stated by the encyclopaedia, “Why has culture found some many various definitions? The reason is that culture is a homogeneous topic and does not pertain to one individual alone; it covers a great many elements of high diversity, such as ideas, emotions, values, intentions, actions, tendencies and experiences,” needs more accurate consideration, for it is true that the various definitions of culture are not .homogeneous

This best proves that finding a comprehensive commonality among the existing ۱۶۴ definition has not been what all the dictionaries and encyclopaedias have been struggling for. Considering the diversity among human souls, it would be extremely hard to do so, even in case of the examples we have mentioned (emotions, values, .(goals, actions, tendencies and experiences

The theory that “Culture shows the behavioural content of the society,” depicts the .Δ .resulting outcome, of culture, not the facts facing it

In other words, the theory believes that the culture of a society lies in the behavioural aspects of its inhabitants; however. it does not mention the intrinsic factors of culture,



i.e. moral virtues and aesthetic values Considering the principle that “no effect can totally reveal its cause,” our objection is quite justified. For instance, much effort is made

The Encyclopaedia Americana states three points about the evolution of culture

First: “Culture is exclusive to humans, not all living beings

This point, as far as our knowledge of biology is concerned, seems to be totally accurate

Second: “Such behaviour is a result of cause and Effect outcomes in human; physical development

This point calls for a more scientific analysis; if “human physical development” means that a significant extent of cultural effects appear as intrinsic outcomes in the body and its development (such as mental, emotional, etc effects), it is quite reasonable; however, if this means limiting cultural effects in the physique, it would not be acceptable, since human spiritual evolution by means of internal factors such as religion, accountability, morals, love and humanitarianism proves highly more fruitful than depicting physically human cultural development

Thirdly: the fact that “Population growth and the consumption of natural resources, have caused cultural norms to result in a treasure of ideas and approaches throughout history, based on symbols and language,” can also be accepted, except a

short point of interpretation that is necessary about “cultural norms.” Since there is no comprehensive definition of culture in such texts, “cultural norms” remain .unexplained

The text reads, “Considering the vastness of culture, it .v

is not what primitive men invented owing to their needs; culture is a manner-based  
” .phenomenon tending to supply beings with the great moral life they potentially had

This theory calls for more careful attention, for mutual coexistence between men and the serious cooperation and harmony it demanded, was undoubtedly essential; in other words, the gradual necessity of force balance and sacrificing endless personal desires –which caused destructive disturbance –led man to accepting limited desires in order to make mutual coexistence feasible This was the beginning of co- existential culture, which was established by men in completely free will, not by force. The text then states, “Man, who is able to build tools, and use them in different jobs, can definitely also think of various ideas, interrelate them, and come up with new ones.” Obviously, as the need for physical tools existed, human spiritual life also needed the .most basic cultural factors

Delicate philosophical ideas and elevated religious beliefs are generally intertwined“ in legends, like an ore containing both coal and gold. Unless mythological analyses separate myth from ideological units, it would be impossible to explore the treasures .of human thought buried in legends

Regardless of the entertaining lullaby-like aspect of myths and legends, in fact, it is the existence of such highly original thought supplies unconsciously lying in various contexts that makes studying mythology inevitable for researchers of the history of the development of philosophical schools

Some experts have come to believe that primitive men struggling with their surroundings, either found no chance to discover their spiritual truth, or felt no desire

The economic and materialistic aspects of human life have apparently in the course of time turned into the transform of his natural environment into greater wealth and luxury. Aspects of culture such as arts, research and philosophy have developed in some periods, but their continuity is doubted. All in all, cultures of the world are losing their absolute diversity

As modern industrial lifestyles spread throughout the world; much rare cultural diversity have been sacrificed to make way for industrial civil life. Anthropologists and historians believe cultural variety to have been at its peak during the 14th and 15th centuries –shortly before European began to infiltrate the lifestyles of other countries

:There some points in the above statements that require further study and criticism

The statement, “Cultural variables are based on creativity and imagination” is generally correct and acceptable, but the point is that the cultural constants inside humans need to be discovered and distinguished from variable cultural examples; the above statement not only ignores this point, but even makes it more mysterious later

on in the passage: “All in all, the cultures on earth are apparently losing their diversity

b) The text reads, “Man can conceive almost any behavioural state or interpretation  
of human life

The above sentence is somewhat ambiguous, for if the physical outcomes of human behaviour are meant, they are obviously noticeable through studying ideas and senses by means of behavioural research. And if the focus is upon the total identity and internal and external results and reasons for human behaviour –as most scholars around the world have admitted, the number of human faculties and capabilities that still remain unknown far exceed his known abilities; such a general statement would  
.require revision

This is also applicable to the next phrase– “interpretation of human life,” for our knowledge of the true nature and factors of the existence of living beings is extremely meagre, so our interpretation of life would be highly limited and superficial. Let us  
:consider the theory proposed by a distinguished Russian biologist

Every object in the world can be thought of as both living and lifeless. Accepting such an approach makes such questions like “What is life? What objects can be considered  
”?alive, and which cannot? How did life arise

The encyclopaedia unfortunately refuses to mention any of the causes or positive  
negative outcomes of its predictions

We must first address the problem whether cultural diversity on earth is deteriorating  
by itself, or by fate, or powerful dictators striving to strip man of any freedom, dignity  
?or the life he deserves

We then face the question whether industrial societies spreading throughout the  
world will destroy only the rare differences or influence all cultural distinctions and

In other words, if Western industry dominates the world, we would face a clock work  
of machinery instead of man or humanity. If such a vision embraces reality, and man

or be destroyed; if the latter proves true, the world would turn into a huge industrial factory, which may continue functioning until its resources run out, but will eventually .destruct; that is, of course, if the greedy dictators allow life to last so long

On the other hand, if the motive for life survives, it will overflow time and time again, bring industry under man's control and prevent life from being sacrificed by ignorant dictators and anti-moralist gluttons for power. The encyclopaedia presents a definition of culture in order to elaborate cultural . styles, but does not explain the nature or fundamentals of culture

After our study and criticism of the treatise on culture presented in the encyclopaedia, we may undoubtedly claim that since the main issue here is mankind, it is impossible to achieve any acceptably true facts about the highest of human concepts –such as culture, just to name one –which all nations, even the most industrially sophisticated, may agree upon unless we all come to an agreement on the identity and .characteristics of man

### **Culture Seen by the International Grolier Encyclopaedia**

In biology, culture refers to a group of living cells or organisms grown artificially, such as several kinds of micro organisms like bacteria, yeast and fungus growing and :reproducing, in a medium. The word 'culture' has two main applications

It refers to any product of a great civilization, such as art, literature or philosophy; .1  
.therefore, it could colloquially refer to highly educated persons

Anthropologists use the term 'culture' to distinguish man's history and life. For .2  
instance, the creation of ideas, thoughts, habits and objects leading to man's ever-  
.complicating coexistence with his surroundings

In this book, we shall deal with the second meaning of culture, which has academic  
.and historical usages. The latter meaning of culture leads to three major domains

,a. culture as an evolutionary concept

Civilization is a term similar to culture, except that civilization pertains to highly sophisticated patterns of life, whereas culture is a way of life; whether simple or consisting of detailed ideas, culture is made up of ways man has learned to behave, .(feel or think (and not his involuntary biological functions

Any human being works

understands and thinks in a manner that shows his culture. In other words, culture refers to functions man as learned to work, understand others or express his ideas more efficiently

Some animals, guided by their genetic instincts, follow certain patterns of behaviour. Animals naturally inherit the methods of searching for such requirements as food or shelter. The distinctive point between man and animals in this case is that man is capable of experiencing alternative methods for providing his shelter and achieves better results through his own attempts. There is no end to man's struggle towards faster, easier and better achievements. Culture consists of a series of experiences .acquired by every part of the human body

Sigmund Freud, the well-known Austrian psychologist, sees culture as an artificial instrument man uses in order to improve his physical faculties (like dentures or glasses). He believes culture, like any other man-made tool, enables him to do what .his body could not manage

For instance, if man had arrows, he would not require forks or hooks; if he had tame horses, he would never have to run; and without culture, he would not be able to send astronauts to the moon and provide them with enough technology to survive

The human body needs oxygen, a certain temperature and many other necessities in order to remain alive. Likewise, man-made instruments and other cultural facilities "enable him to overcome the limitations of his unpleasant surroundings and survive

The text finally introduces Freud, who considers culture equivalent to the most  
normal of tools and absolutely natural phenomena limited to the physical aspects of  
.man's life. The most significant definition given in the text pertains to Tyler

Surprisingly, the fourth

definition contradicts the fifth; the fourth definition separates man's “naturally  
biological” functions from culture, whereas the fifth –particularly Freud –says nothing  
.about supernatural phenomena or facts

### **?How Does Culture Change**

All cultures are constantly changing. Changes may happen rapidly or slowly. Since  
culture consists of various factors, changes in one will also affect the others. Some  
sociologists believe much social maladjustment is due to unequal changes in different  
cultural components. When some parts tend to lag behind others, cultural retardation  
develops. Most of the cultural retardation observed in the history of the United States  
concerns ideas, traditions and mental matters. Science and technology advances so  
.rapidly that it often overtakes culture and leaves it behind

Therefore, guiding the leaders of technology today –who lucratively provide

themselves with power and authority –toward more consideration for human culture and moral virtues may prove in vain, or perhaps cause them to become even more resistant toward it, and strengthen the advance of technology. Therefore, it is best to address societies where the fundamentals of human culture still exist, and hope for a .day when they lead a cultural renaissance

A point ought to be emphasized here, although we will address the issue when we explore disharmony in cultural elements. The point is that unfortunately, scholars currently presenting definitions and characteristics for culture do not distinguish the .stable sections of culture from its variable parts

The unchangeable cultural elements depending on man's fixed needs should be distinguished from the change-prone elements; however, the two are usually integrated, which leads

As well as being a true fact existing outside man's physique, culture also has“ .2 mental aspects.” This is absolutely correct, and we will address it later on in our [discussion entitled: “Culture is a Bi-polar Truth.”](#)[\(3\)](#)

Culture is also a historical reality.” Considering the definition of culture and its“ .3 .historical effects, it is obviously a reality arisen from man's original needs

Intellectuals are mostly unable to understand the comprehensive identity of“ .4 culture.” The reason is the great diversity among cultural elements and outcomes which inhibit a comprehensively common concept. However, if we consider culture as a progressive reality, we may present a definition based on the one given during the first sections of this book, which can include all of the elements and outcomes of :culture

Culture consists of the appropriate qualities or meritorious methods for man's" spiritual and physical activities, based on logical thinking and emotions arisen from ”.sensible evolution

The other reason mentioned why the comprehensive identity of culture has not .5 been understood, lies in cultural invasion -and also due to Imperialistic cultural invasion. “We have already mentioned that the issue currently is not cultural invasion, but deculturization, for in order to generalize and globalize culture according to the definition above, obviously invasion and opposition are totally unnecessary, for all of mankind eagerly desires a culture so developed that it would guarantee their spiritual .and physical evolution

moral, political, literary, artistic or religious development of man, for the motto of  
:pursuant culture can be defined as

By mass-producing publications and films, they are constantly deteriorating the“ .۷  
minds of the masses. A mirage of a

luxurious life is created through showing fairy tales of big city life in Imperialist  
centres. Millions have been infatuated by American lifestyle propaganda, and have  
”become estranged with their own culture

Such statements need no further comment. However, those who lead the operations  
aimed to destroy other cultures should have in mind that all human societies resemble  
a swimming pool, if in which a small stone is thrown in its corner, waves large and  
small will diffuse in all parts of the pool. The adverse results of destructing cultures will  
definitely infect all human communities. Once, a father got angry with his young son  
and said, “I will take you by the ear and swing you around the yard.” When his son  
asked, “If you do so, father, will you swing, too?” The father immediately let go of him.

This magnificent statement reflects its writer's deep thoughtfulness and sense. It is  
clear that pioneer cultures affect human souls so profoundly that their destruction will  
.lead to the deterioration of man's own identity

Foreign and native cultures still divide people into separate groups, which are“ .۹  
”constantly in conflict

.Cultural conflicts can damage every aspect of people's social lives

### **Culture in the Encyclopaedia Britannica**

Culture can be defined through man's behavioural characteristics, as well as other“ factors affecting his behavioural development, especially culture, language, ideologies, habits, traditions, laws, social organizations, devices, techniques, works of

art, religious rituals, ceremonies, etc. The existence and the application of culture strangely depend on a particular human faculty, which is commonly called the .capacity for sensible or abstract thought

However, since strong evidence of sensible thought has also been reported in animals, the meaning of “abstract” falls into doubt. Therefore, we had better express man's unique capability to abstract through the term “symbolizing”. Symbolizing includes selecting symbols to represent specific objects or events unable to be .realized through our senses

A good example is verbal eloquence. The sound included in the word “dog” provides no hint of its meaning. Obviously, its meaning arises from a conventional agreement selected by humans. Symbol selection is behaviour independent of the physical .senses

:As Edward Burnett Tyler, the English anthropologist stated in 1871

Culture consists of a complete series of knowledge, beliefs, arts, morals, laws,‘ traditions and any other abilities, capacities or habits acquired by man as a ? .constituent of his society

According to Tyler's definition, culture is attainable only by humans. His statements won the approval of other anthropologists for fifty years. Advances in anthropology, however, led to deeper studies on identity and concepts and in turn various .definitions



In 1952, two American anthropologists, A.L. Kroeber and Clyde Kluckhohn cited 164 different definitions of culture in their work, *Culture: A Critical Review of Concepts and Definitions*.

In their view –and also as many other scholars nowadays see it –the best definition of culture consists of an abstraction; to be more precise, abstract human behaviour

p: 42

Such concepts prove to be either incomplete or vague. The existence of behavioural patterns –frameworks of behaviour, whether inherited genetically or acquired socially –have been undoubtedly proven in non human species (e.g. honeybees, ants and termites).

The abstract concept of culture poses first the question culture is real (for abstraction is at times considered inconceivable); secondly, it defies the existence of culture. Therefore, as the non biological science of mankind, culture cannot exist without real visible phenomena, for it has been regarded as both real and nonexistent.

Kroeber and Kluckhohn eventually concluded that if culture is regarded as equivalent to behaviour, its identity would bring it into the domain of psychology. Therefore, their conclusion was that culture consists of abstractions of observable behaviours.

Now rises the question how we would abstract wedding rituals or pottery according to Kroeber and Kluckhohn's pattern? Such questions lead to problems they have not considered. Perhaps Leslie A. White's solution in his 1959 work, *The Concept of Culture*, may prove useful. White argues that, “The point is not whether culture is indeed a reality or a mental concept; its scientific interpretation should anyhow be carefully studied. Anything or any event leads to behaviour when studied in relation to human organisms.

When studied not in relation to human organisms but to others, it becomes culture – for instance the prohibition against marrying one's mother-in-law or stepmother

consists of a series of concepts, attitudes and actions. If they are regarded in relation to human organisms, i.e. the

.organism's functions, they can be named behaviour

Therefore, if we consider the prohibition against marrying one's mother-in-law or stepmother in relation to social compositions, settlements, traditional segregations of man and woman and their roles in society and upholding the good, it could be regarded as culture

This distinction has been used for years; many words are considered behaviour due to their pertaining actions. However, if words are considered in relation to each other –studying their lexical definitions, grammatical and structural usage –they will become part of language, and would enter not only psychology, but also linguistics. Thus, culture is a term referring to a category of items and events depending upon conventional symbols studied in a framework of the supernatural content of man's life

Now let us consider the points of importance presented in the Encyclopaedia Britannica

Culture can be defined through man's behavioural characteristics, as well as other“ .۱ factors affecting his behavioural development, especially culture, language, ideologies, habits, traditions, laws, social organizations, devices, techniques, works of art, religious rituals, ceremonies, etc

:The problem with the above statements is that

a. Including culture in its own definition does not seem to make sense, for the defining items ought to be clearer than those which are to be defined; using an object to elaborate itself traps us in a vicious circle

b. Including particular human behavioural patterns in the definition of culture is not

sufficient, for such patterns, e.g. language, belief, and habits, express only a few of  
the results

of culture, not culture itself: “The existence and application of culture calls for a  
”.uniquely specific human faculty

Obviously, unless that unique faculty is known, the true identity of culture would remain unsolved, particularly since the results of cultural elements are so diverse that sometimes it is impossible to combine them into one general concept that can be called the identity of culture. For instance, works of art that oppose morals or religion cannot be united to convey culture. The encyclopaedia thus elaborates on the cultural  
.faculty

”Such a faculty is commonly known as the capacity of logical or abstract thought“

It then objects to this term, and adds, “However, there is proven evidence of logical  
”.thought in animals, so the meaning of abstraction here is unclear

We must say that even if living organisms other than man possess the faculty of logical thought, they would be incomparable to man, for human thoughts are conscious, and definitely use abstract principles. In nonhuman life, as far as we know, it merely moves from the beginning steps to results; in other words, their actions aim for providing the beginning steps, like nesting as a preliminary step towards mating  
.and reproduction

However, the statement, “The meaning of abstraction is unclear” reflects an obvious mistake about the delicate functions of the brain. Some people think that the functions performed by the brain and everything pertaining to the “self” can be  
.studied by the same methods used for physical phenomena

They ignore the fact that

we will never be able to discover the true identity of self-consciousness. However, a developed brain is not only self-conscious, but also capable of understanding and performing abstraction. Describing such internal functions is as hard as explaining joy, sorrow, surprise or responsibility

c. “Thus, symbolizing is a more suitable term for expressing the unique capacity for abstraction in men

We must remember that symbolizing, as other words, is just a conventional term, and cannot reflect its content. Two illustrating examples can elaborate this point in the subsequent sentence

Culture is “a complete set of knowledge, beliefs, arts, morals, laws, traditions and any other capacities or habits acquired by man as a member of the society

If the above-mentioned phenomena refer to interrelated realities affecting each other's qualities and also quantity, their combination can express the unique reality named culture; however, we have already seen that deriving a definition of culture is not possible merely through determining one or several culture phenomena

The statement, “If we could maintain a relationship with the whole identity of culture through identifying cultural phenomena, we would no longer need to fully comprehend the definition of culture” is incorrect, for it is based on the false premises that we can establish a relationship with the whole identity of culture by identifying a few cultural phenomena; the ability to figure out the true identity of objects merely by studying a few of its effects is a grave mistake. In proof of it, we must say

### **Man Innately Desires to Figure out the Truth about Elevating Culture**

is proven clear to any researcher on culture who has accomplished discoveries about it that without culture, man would not only lose his dignity, self-respect, his valuable

“freedom” and the life he merits, but even consider them as harmful hallucinations; as we all know, if such basics of life vanish, the only logic remaining in man's individual or social life would be the passageways to nihilism, power and pleasure. Obviously, if power and pleasure dominate man's life, no necessity or meritorious value could prevail, and even their opposing factors would also be demolished, even though they  
.may be justified

It is amazing that most academic authorities on the –humanities still continue to attempt to prove the fact that man is heading for true greatness, with such deceiving eloquence that any simple mind believes them. Some put on such a detailed display of complex jargon that even other scholars might be forced to assume it to be  
.unquestionably true

High claim for man's progressive evolution aims to sacrifice all of the cultures and peoples around the world –who basically agree on logical principles –to feed their technological monster. One day, the monster might strangle its own operators to death, and eliminate any chance for them to relive their painfully eventful story which  
.ends in suicide

A significant point comes to attention here, which can also influence human life evolution: all around the world there are hundreds of seminars, conferences, and vast  
,studies on man and his relationship with technology, and still

there is no indication of a serious attempt to discover a reasonable identity of culture and its relation to mankind. Perhaps the few honest authorities on humanities are  
.totally in despair about the unstoppable demise of humanity

Therefore, let us uphold our heart-warmingly reviving culture and introduce it to other people, and have community leaders do their best to help the process before it is too late. Then, they will definitely admit that ruling over one human being who enjoys dignity, logical freedom and the life he/she deserves, is better than ruling over millions devoid of them, who have only been labelled “human” by history after the

As Kroeber and Kluckhohn and also many other currently leading scholars see it, “the best definition of culture consists of an abstraction –to be more precise, an abstraction of human behaviour .” If the above sentences refer to a dimension of reality, not only is it generally correct, but in fact Kroeber and Kluckhohn have pointed out an important aspect of culture (the internally innate pole) which is also the abstract aspect of culture

This is an absolutely correct point, for the non-instinctive, calculated movements and accountable behaviours observed in some animals, refers to meritorious values conveying the general concept of culture, which is undoubtedly abstract (as is the general concept of beauty

The regular behaviour seen in honeybees, ants and termites depends on their unconscious instincts, not conscious merits or freedom; therefore, if Kroeber and Kluckhohn believe the abstract definition of culture

to be the best one, they are gravely mistaken. It would be like defining beauty as “an abstract concept”, which reveals nothing at all about the qualities or identity of beauty

In brief, we must note that the general truths about culture –beauty, greatness, etc – consist of two poles

The first, the innately internal pole, which includes mentally abstract concepts describing general definitions. The other pole is observable, i.e. those behaviours and effects seen physically

Thus, we may put the theory of culture being an abstract concept in the encyclopaedia in opposition with Kroeber and Kluckhohn's viewpoints. The encyclopedia states that

The concept of culture as an abstraction poses first the question whether culture is  
".real (for at times. abstraction is considered inconceivable), and then defies it

The authors of the encyclopaedia must keep in mind that defying abstract realities  
such as culture, beauty and greatness could first cast doubt upon all scientific  
principles –which are definitely derived from generally abstract issues and regular  
phenomena in the world and then even question the integrity of mathematical and  
geometrical laws. Such a presumption could put all of human knowledge and  
everything man has acquired through mental abstraction in the shadow of serious  
.uncertainty, or even defy them all

The encyclopaedia states that, "Therefore, as the non-biological study of mankind, .f  
culture would be consistent both nonexistent and real, and could not remain without  
".actual worldly events

Unless interpreted correctly, the statements above could prove unreasonable, for if  
we judge the reality of

objects biologically, we would have to defy all of man's psychological activities, for  
.they are non-biological

It is scientifically reasonable to accept the existence of internal, psychological and  
mental facts, even though their external effects would require observable behaviour  
.and imagination in visible phenomena

The statement, "Therefore, Kroeber and Kluckhohn concluded that culture is an .g  
abstraction of observable behaviour" flaws in its sense-based deduction is that  
Kroeber and Kluckhohn have neglected the distinction between the facts that  
"Observable behaviour provides the basis for abstract mental realities like culture,  
."beauty and justice" and "Observable behaviour leads to the abstraction of culture

Scientific observations and analyses on abstract facts have shown that culture,  
beauty, justice, etc, are bipolar abstract facts (consisting of virtual and observable

poles), and the resulting behaviour account for the observable one. It is incorrect to suppose that such realities arise from abstractions of observable behaviour

We may conclude from the above item that Kroeber and Kluckhohn's conditional theory – "If culture is regarded as identical to behaviour, it would naturally become a psychological issue" – calls for some rethinking, for bipolarity should not make culture a domain of psychology, as is the case in beauty consisting of two poles (internal virtues and external virtues)

However, such issues can be studied in terms of psychological and also scientific matters, but they do not necessarily afflict their abstract reality

The text reads. "Perhaps Leslie A. White's suggestions presented in his 1959 work, *The Concept of Culture*, may provide a

solution. White reasons that it is important to take into consideration the scientific interpretation of culture, not whether it is a reality or just a mental concept

This point also needs to be modified, for in order to fully comprehend the scientific interpretation of culture, it is at least as important as other essential factors defining culture to determine whether culture is a really external fact or just mental– if not the most important, for the qualities of a mental fact highly differ from those of physically observable ones, even if the two share a common abstract concept. It then adds

Whenever objects or events are considered in terms of their relation with human organisms, they lead to behaviour. Otherwise, i.e. when they are considered only in relation to each other, they would by definition result in culture

The point rising here is, what is meant by "objects and events" in relation to human organisms? If they mean all– external or internal –factors and motives, the point would prove to be true, for human organisms are obviously prone to any external or internal influence, which lead to behaviour, whether being merely a reflex or causing mental or bodily functions. However, if "events and objects" convey externally



physical phenomena, they would only account for a certain extent of behavioural factors

On the other hand, the statement, "If studied independent of human organisms –i.e., only in relation to each other –they would by definition result in culture," is somewhat unclear, for billions

of the components of the universe are constantly affecting each other, but many of such effects may not fit into culture. As we have already seen, the primary basis of culture is the virtually internal pole relating to human life merits such as "What it is like" and "What it should be like", which lead to man's aims and ideas in such issues

Thus, culture is a term referring to a class of objects or events depending on "conventional symbols considered as part of man's supernatural content

Culture as seen by Russian Encyclopaedias "Culture is a series of social achievements consisting of physical or mental advances used by the community, and also those cultural traditions serving man's future progress

In societies suffering from struggling classes, culture inevitably becomes class-biased. The opposite of culture is barbarity, savagery or cultureless ness. A true understanding of culture is only feasible on the basis of socioeconomic guidelines and sequences of social organizations brought about by defining productive forces, production processes, social relationships and the qualities of any given society

Yet, culture cannot replace these concepts, for it includes all achievements of any range –mental or physical –altogether, whose characteristics determine historical periods for various societies, peoples or nations

Culture consists of man's creative activities, and is the most significant sign of his advance level. Culture derives from the Latin word cultural (agriculture), which means mowing, producing and processing; it originally conveyed man's influence on nature, determining his achievements and the factors playing a

role in them. The latter meaning was most used in the bourgeois culture era, and was seen frequently in the works of ۱۹th century historians, anthropologists and archaeologists, which led at that time to the term “The History of Culture

The concept of culture consists of two parts, physical and mental. The physical aspect shows man's ability against the forces of nature. Physical culture conveys man's progress in understanding nature, the community, and also the scope of his vision and progressive thoughts and knowledge. Tools are the most prominent symbol of physical culture

Mental culture consists of social achievements in morals, arts, science and philosophy. It also represents man's political and legal relationships and advances. Mental culture is used to determine the extent of progress made in social, political or legal relationships. Language, speech, thought, logic and behavioural principles make up (the phenomena of human life.” (۱

:The following comments may be presented on the above statements

It is true that culture is of high importance in man's progress, and as a principle, the main role of culture is to be progressive

However, what eventually can be named pioneer culture? The question is left unanswered

The statement, “In societies suffering from class struggles, culture inevitably becomes class-biased” is correct from a certain viewpoint, but on the other hand also calls for reconsideration. What is meant here by “struggling” classes? If the struggle involves positive competition instead of harmful conflicts, culture can definitely serve the development of such a progressive

society. Also, if we were to have a systematically organized community, culture would again prove to be dynamically progressive, and aim for the advancement of the whole society.

”The opposite of culture can be stated as barbarity, savagery, or cultureless ness“ .۳

The important point seen here is how meritorious culture is, despite those who regard it as social customs and traditions. No matter how deserving and elevating social traditions may be, we based the definition of the identity of culture (given at the beginning of this discussion) upon its meritorious ness. Therefore, since the highest human virtues and principles make up culture –and defying them would defy the whole of humanity – “The opposite of culture is barbarity, savagery or cultureless ness”.

:Further on, we encounter two contradicting statements .۴

a. “A true understanding of culture is only feasible on the basis of socioeconomic guidelines and sequences of social organizations brought about by defining productive forces, production processes, social relationships and the qualities of any given society”.

b. “Yet, culture cannot replace such concepts, for it includes all achievements of any range –mental or physical– altogether”, for understanding a true fact means acquiring knowledge of it without the influence of any presumed principles or accepted ideals

In other words, it is scientifically vital to strongly avoid using our physical senses (laboratory devices, tools enhancing human senses, etc) as much as possible to discover realities as they truly are. By gathering more experience and knowledge, we can free ourselves from

.knowledge (as its spiritual aspect) to developing tastes and attitudes

As a generalization of the above statements, we come to the culture of a nation, era,  
.or cultural development and the history of culture

In anthropology, as well as sociology and psychology, culture

Clearly, although this definition presents some components of culture to a certain  
extent, the identity of culture –the main core of the definition –remains unmentioned  
.nevertheless

:Two points are worth considering

- a. It is undeniably true that acquiring the whole of mental or social knowledge  
.requires vastly extensive study
- b. Such vast studies would still prove inadequate for achieving complete mastery of  
.culture and its components and outcomes

A cultured person aims to develop intelligent thought in himself, feel it flow through“ .2  
”.his body, and use it to quench his mental desires

This statement shows man's authentic eagerness for culture. Indeed, when man  
selects his culture consciously and freely, he must have found it sufficiently deserving  
for him to feel it flow through his body and quench his intellectual needs with it.  
Obviously, no sensible person, consciously aware of his benefits and perils, would  
choose an animal or filthy quality as his culture, or become so attached to it that it  
would flow through his/her veins. This is the virtual meritorious ness a dynamically  
objective human culture should have. Otherwise, the significant species known as  
“homo sapiens” would definitely disappear

The most dangerous enemy to man is fashion, which demolishes all cultural“ .۳  
”values

If only today's cultural leaders would carefully and adequately consider this critical issue –the conflict between fashionism and a dynamic, objective culture they could save mankind from a hemlock that deviates man's spirit from following his virtues, pulls people so deeply into consumerism that it demolishes their health, possessions and dignity, throws their spirit into the darkness of despair and infidelity, wandering in .artificial ruins made by their greedy rulers

As the encyclopaedia states, “Fashion is always substituting novelties for the old”; therefore, fashionism and dynamic, original cultures would always conflict, for if man does not use his enormous sense of novelism in order to gradually renew his spiritual and psychological virtues, he would undoubtedly apply it to superficial fashion games. Cultures of dynamic originality are based upon fixed principles much higher than changes in appearance. The encyclopaedia puts it very delicately: “Fashion can even  
”.destroy itself

The history of culture is an average of the tastes, knowledge and moral and/or“ .۴  
”.religious beliefs existing in a certain location and era

Provided that the above statement is based on the permanent principles of the culture, it would be perfectly correct: the history of the culture of a given society at a certain point of time and location can be expressed by the average of tastes, knowledge or moral and/or religious beliefs based on permanent human principles,  
not the average of

variable, baseless outcomes of alien cultures spreading from one society to another. If it is not stated it the basis of fixed principles, however, it would prove prone to .defiance

As an indication of one of the aspects of culture, this statement is correct. But further elaboration on "intellectual thought and its reflection upon a generation or a country", especially "intellectual thought", may reveal one of the most important constituents of  
.the definition of culture

Culture is not only a mental issue, but also spiritual, relating various branches of " . knowledge (as its spiritual aspect) to developing tastes and attitudes. As a generalization we come to the culture of a nation, era, or cultural development and  
".the history of culture

These valuable statements prove that the identity of culture does not only reflect the thought of a community; likewise, the thoughts of the members of the society cannot represent their culture either. The spiritual aspect of culture, i.e. man's evolutionary development towards high moral virtues, consists of an important part of culture, and  
.would be worthless without it

### **Culture as Seen by Greek Reference Books**

Of Latin origin, culture means agriculture. In the last two decades, however, " ideological and social class changes turned it in Greek into cultural, which means agriculture, and also physical and mental development through education, evolution, .culture, and intellectual training

,Greek dictionaries provide agriculture, education, training

culture and civilization as its synonyms. Occasionally, when one is labelled as culture yaris, it humorously means a person pretending to be interested in cultural matters in .order to show off before others

In Greek, culture is seldom consisted of a series of meanings; for Greek is such a

vastly rich language that there is a specific term for each object or concept; therefore, the five synonyms provided for culture are easily applicable to their proper cases, each of which convey a certain aspect of culture

Here are the three most significant points arising from the definition of culture in the Greek Encyclopaedia

a) Its cultural elements are mostly of evolutionary value, and the world “development” is stated

b) It introduces “intellectual training” as one of the concerned parts. Obviously, “intellectual” cannot be limited to mere thought, but must include mental activities based on moral virtues

c) Culture conveys variety: "In Greek, culture is seldom consisted of a series of meanings, for Greek is such a vastly rich language that there is a specific term for each object or concept

We will discuss this significant point further later on

### **Culture as Seen in Spanish Encyclopaedias**

The Royal Spanish Academy's Dictionary metaphorically describes culture as “the result of developing human knowledge and perfecting it through practice

Space Calpe, the best-known Spanish encyclopaedia available, defines culture as being “the mental or physical developmental state of a nation or peoples

The encyclopaedia considers illustration (illustracon) and civilization as synonyms for culture. Salvat presents a philosophical definition of culture

The series“

of definite productions of humans as creative beings able to change themselves as well as their surroundings



The definition provided in the Royal Spanish Academy Dictionary is more likely real than metaphorical, considering its frequent usage and approval by the Space Calpe. Perhaps this mistake (which also occurs in the French encyclopaedia) lies in the lack of distinction between a word's actual meanings at a certain time with those other points of time, which is caused by the expansion of the depth of meanings of a word as time goes on

Considering the Latin origin of the word – meaning agriculture, fertilizing, and raising plants and living beings – the subsequent meanings of culture arisen in Eastern countries may also be associated with the original ones as its examples, results, or even real meanings education, fertilizing human knowledge, or purifying it through practice. If there were nothing in common between its new meaning “the mental or physical developmental state of a nation or peoples” and ‘civilization’ and its old ones, even if the older meanings were contradicted, they would still remain real. In other words, culture would be a verbal portmanteau among various realities

The second statement, “The series of definite makings of humans as creative beings able to affect themselves and their surroundings” also depicts the element of man's innovativeness and his capability to change his environment

### **Culture as Seen by Chinese Encyclopaedias**

The Sea of Words thus defines culture: “All of the physical or spiritual wealth created by man throughout social history consists of

culture. Culture is a social phenomenon, and each society possesses a culture appropriate to its own social physical development. As an ideology, culture represents the politics and economy of the society, which greatly affect its socioeconomic survival. In class-orientated societies, culture also has class-biased qualities

Proletariat culture, critical of man's historical achievements, makes use of all the experience gained from class struggles, productional struggles and academic experiments and develops

:The above definition brings us to several points

The statement, “All of the physical and spiritual wealth created by man throughout . ۱ social history makes up culture” implies that The Sea of Words considers all of these treasures as culture; in other words, each of these components cannot individually be culture. Unless, of course, supposing the components of the definitions were not related, and the omission of any of them would not demolish culture. Therefore, it is obvious that we literally mean “all”, and culture includes each and every one of its .components

In order to define the identity of culture by using a definition, the words forming the .۲ definition should be clearer than culture (the “defined”); yet, culture nowadays is more easily understood than words like

.all of the physical and mental wealth”, etc. by people“

?How can physical wealth possibly be included in the meaning of culture .۳

Culture is a historical phenomena.” This is absolutely correct, provided that we“ .۴ accept that culture arises, continues and evolves throughout history, rather than being fatalistically brought about by it, for

our definition of culture was based upon “qualities” and ways of a meritorious, sensible life. Therefore, since fatalistic phenomena totally ignore values and merits, .culture cannot depend on fatalistic historical factors

Each society possesses a culture appropriate to its own social physical“ .۵  
”.development

.The following point shows that this statement calls for revision

The fact– that each society has an appropriate culture of its own is not applicable to all cultural phenomena or elements, for throughout time and even today, human societies share a series of cultural commonalities like literary culture, artistic culture,

moral culture and ideological culture; although each of these concepts differ characteristically in aspects such as literature, arts, morals and ideology, cultural diffusion from one of these aspects to another in one society or among several societies is quite common

If nations and peoples were not basically so common in culture, today's vast mutual cultural understanding could next exist. The phrase "social physical development" verifies our point, for if we were to evaluate a society's cultural development on the basis of its physical production growth, finding a few common points of qualitative and quantitative growth among some societies would definitely lead to common cultural elements

As an ideology, culture represents the politics and economy of the society, which " greatly affect its socioeconomic survival

In comparison to an original Chinese economic, political and legal theory –"Economic affairs, especially those concerning production and its tools, quality and quantity make up the most fundamental element of every aspect

.of human life, whether economy, politics, morals, law, etc

The above statement is contradicted, for it believes that culture (an ideology) determines the socio-politics and socioeconomics, whereas the theory states that politics, economics and even culture are reflected by fundamentally important economic affairs. The current harmony in manufacturing methods and financial viewpoints and also the vast difference existing among cultures and ideologies requires more careful attention

Due to its political viewpoints, the definition provided for culture in the Chinese encyclopaedia has undergone deep reconsideration by scholars today. However, had Chinese scholars considered their vast history and culture more carefully, they would have found an incredible wealth of cultural elements rarely found in any other society.

Perhaps the originality of diverse cultures in China has led to the tumultuous early to mid-20th century cultural diversities

:As The Ancient History of Chinese Philosophy reads

The general trend during this era was destructively sceptic, casting criticizing doubt upon all basic foundations, even family and marriage. Liang Chi Chao (1873-1929), the well-known scholar, compares it with the Renaissance in Europe

Indeed, all of the thoughts of this era are closely related to the socio-political events occurring then. Christianity has found strong support in China, bringing with it Western knowledge and philosophy, particularly John Dewey's pragmatism and Karl Marx's dynamic theories; both have had profound influence upon Chinese intellectuals. Distinguished writers like Tolstoy, Ibsen, Guy de Moupassant, Shelley, Emerson, Marx and Engels have had a strong effect on causing such a novel atmosphere." (1

The ideas of such personalities would definitely differ a great deal, or even contradict. Merely supposing that they were influential in the Chinese society, sufficiently proves that China must have possessed a culture to prepare its intellectuals to accept such a vast range of diverse - or contradicting - schools of thought

As we will see, a certain viewpoint rising in order to determine the fate of culture cannot destroy the original cultures of a civilized society

Philosophy develops alongside other political, social, religious and artistic changes, all of which are used to depict the culture of a country. Therefore, it would be natural for a primary school of research criticism to arise during this last phase of total changes, and put the new Confucian eras of Song and Ming up to ridicule

They are China's most meticulous critiques ever. Although their radically critical

ideology can be regarded as pragmatistic, it would still not qualify as a philosophical school of thought, for it emphasizes the study of language and criticizing texts rather than truly- philosophical research. Criticism, in fact, as the most effective motivation .during this era, could itself lead to a new school of Chinese philosophical principles

The consequent effect of such critical spirit is the movement entitled “New Culture.” Its leaders, hailing Western positivism and pragmatism as their major inspirations, and the knowledge of social development and democracy as their goals, regarded the Confucian primary school equal to their predecessors' conservatism. “Down with Confucian and his followers,” was their motto. However, it was not easy to demolish the ideals –of millions of Chinese people, and a struggle began –and, sadly, still goes .on

Once, all was turned inside out, except for China. Now, however, nothing in China has escaped change. The most conservative nation in history has become the most

radical, and tends to demolish all traditions, once regarded valuable, all organizations, monuments or moral and virtual norms. However, it is not possible to destroy ancient ideas and customs established since the era of ancient philosophers, and replace them with Marxist ideological brainwashing. The old virtues and morals still remain engraved in peoples' minds. The Chinese prefer harmony, compatibility and composition –none of which fit into Marxist ideologies. Knowing this, Communists have attempted to adapt Marxist-Leninist theories to suit traditional Chinese humanitarian .beliefs

This does not mean that Chinese philosophy is robust, for as we have already seen, it .is all but that

Although Chinese philosophy – as of other nations –has suffered much change and upset, very seldom has it adopted anything from foreign cultures without adapting it specifically to Chinese philosophy. In fact, the natural harmony within Chinese philosophy is the key factor to its flourish. Any influences not adjustable to its

evolutional harmony have faded away.”

As Durant quotes from Hu Shih:

Taking the innovative trends of philosophy in 5th, 4th and 3rd century China into “  
” consideration adds to its respect

We must state that Hu Shih, although a pioneer of the “New Mutiny Movement”, has  
intelligently recognized how worthy his predecessors were, and thus expressed the  
:most important issue in his country

If accepting a new civilization would mean uprooting the old rather than combining“  
with it, mankind would undoubtedly suffer extremely heavy losses.

Therefore, the real question is how we can adopt

Culture has thus been defined in Japanese reference books: “Efforts towards making  
.use of nature or natural resources in order to improve man's life

a. Knowledge, arts, religion and man's spiritual achievements

b. Technical achievements equivalent to civilization. The word culture means

,Civilization .1

Civilizing, and .2

In the above-mentioned definition of culture, both bringing into use natural talents and resources in order to improve man's life, and the highest human capabilities, talents and phenomena, e.g. science, arts, religion and other spiritual achievements .have been included

In item b, civilization has been cited as one of the meanings of culture. Civilization, growth, evolution and development and other such concepts can all be regarded as results of culture, for culture –by definition(१) –is what links all definitions; culture determines a society's goals and ideals, and indicates guidelines and motives to attain them. However, we must keep in mind that the results –civilization, development and .evolution –in turn affect cultural elements

In all, the definitions of culture in Japanese encyclopaedias clearly affirm the .evolutional, meritorious reality of culture

### **Culture as Seen in Indian Encyclopaedias**

As a whole, civilization in India is more alive than anywhere in the world, and one of“ the oldest. Few countries have been conquered, and even fewer have such diverse climate, traditions and languages as India. The reason why Indian civilization has survived is the harmoniously structured legends and social values, which have found ,their true identity after fifty years of struggle

customs, beliefs and qualities its nation possesses; Dharma and keeping on with the four balanced aims in life: (1) Artha, the desired ideal, Karma (deeds), Moksa (freedom) and deliverance, all of which rule people supernaturally

The final word on civilizational achievement of India is that one's caste (2) or actions are determined by one's Dharma inductions. Every individual should search, study and eventually elevate a certain series of approved rules and duties based on the necessities of life

In his work Mahabharata, (3) Krishna (4) describes Dharma as a protective activity, consisting of social order and universal harmony, both of which prevail in the Indians' minds. It is such a divinely universal justice that forms the rules making and protecting the universe and logic

Dharma has depicted and adjusted peoples' social life and attempts towards their goals, and has been described throughout history as the undisputed key to the existence of social relationships and liberating forces arisen from mutual dependency and unity

The individual end, attaining perfection, also the communal end in culture, is achieving undisputed balance and reality in man's universal existence and universal society – (paramataman)– worshipped and named Narayana in Indian

The most logical, powerful and glorious representation of Indian philosophy and“



culture is undoubtedly the statue of the heavenly spirit Shivamahayovara (three sculptures in one), located in a temple on the island Elephanta

The main face of the absolute, bright sculpture –tatpuruṣa saśaṣṭiva –does not face any direction, and is located beyond its own limits

Aghora, the figure on the right, looks fearsome, angry and aggressive, and is a symbol of disapproval and destruction. The left figure, Uma, Shiva's bejewelled wife, [\(represents positive games and movements, love and affection.\)](#)<sup>1</sup>

In Indian culture, Uma (also called Sakti), carrying a water lily, is a symbol of Artha and Karma goals. Aghora, the right figure carrying a snake through his fingers, symbolizes Dharma goals; Mokṣa, righteousness and liberty, whereas the main figure –Tatpuruṣa –considers the harmonious and repetitive structure of nature, silence and activity and peace, all to be temporary. Like any other phenomenon, they rise, reproduce and then decompose

Universal legends and forms, along with symbols, statues and the pictures seen in many sacred Indian books have played a significant role in spreading Indian culture, and even provided a framework for studying Asian cultures, and giving them form and structure

More significant examples of these legends are: Jatakas, Puranas, Agamas, Tantras and single texts like Saddharma, Lalitavistara. Only through scholasticism, literature and art can one understand the spirit of India, the inspirations throughout its history and its relationships with the outside world. India's

fundamental cultural references, and all of its classes of people, even those descending from nomadic, Iranian, Syrian or merchant ancestors, sooner or later were dominated by the idea that life is temporary. The necessity of moral virtues

(Karma), emigration, belief in the existence of spiritual social ranks, the sacred and dynamic form of family life and responsibilities, the ideal of brotherhood among men, expressing affection for others, aesthetic attitude towards life and its consequential emotions and desires, have arisen in a both abstract and centralized manner

These social virtues –which form the generalities of a civilization must have been supernaturally human for its basics, unity, expansion and generalization to be used frequently throughout time, helping form empires and renaissances, and keeping people's zeal for life burning in times of despair

### **Geographical Influences upon Cultural Expansion**

Culture is an anthropological term including everything, from the customs people follow when they eat or produce coal to how they construct their buildings; the social, moral and religious virtues highly popular to them, or the accepted trends used to satisfy the more intellectual minds. The fact that India more or less succeeded in protecting its protected cultural evolution, is partly due to the geographical features of the country, whose location has kept it away from excessive visitors

Furthermore, the Himalayan Mountains form a natural barrier in the north of India, preventing invaders and keeping Indian culture quite safe.”[\(1\)](#)

undisputed balance and reality in man's universal existence and universal society (paramataman) –worshipped and named narayana in India – both of which mutually are dependent upon each other

Considering such evolutionary principles, belief in god and the supernatural, we should also take other Indian cultural elements into consideration

Indian culture is incredibly unique among all other cultures throughout the world – whether old and new, Western or Eastern. In a nutshell, all positive or negative capabilities imaginable for man can be seen in Indian culture. It includes a variety of issues, from purely scientific approaches to man and the universe, and even absolutely mystic, philosophical and fictional approaches. As some scholars on India

”have claimed, “India is like a mass of coal containing lodes of diamond

Here, there is a variety of beliefs, from pure idealism to realism, from the goodness of mankind to his lethal threats, and also a vast range of theories, speculations and conclusions on the universe, God, egos and so on

Indian ideologies are mainly religious, and are accepted owing to peoples' religious faith. Will Durant's theory on it is quite worthy of consideration

Religion is incredibly strong and important in India –more than any other country. The fact that Indians have been conquered many times by alien rulers shows that they do not care who dominates or exploits them. The main point was religion not politics; the spirit not the body; the immortal other world, not this mortal, worthless life

When Ashuka undertook absolute

piety, he nevertheless remained faithful to the Hindu religion, which shows the powerful influence of this religion on even the strongest of men. In the present century, again it was a man of piety who united all of India for the first time (throughout its history, not a politician.)

This proves how profoundly critical the role of Islam has been in guiding mankind and uniting religion and politics

Religion cannot merely be regarded semantically, i.e. by only considering supernatural aspects, and ignoring materialistic, economic, legal, political and artistic affairs or issues adjusting human life virtues, for none of man's potentials cannot embrace reality without a logical connection between man's physical, social and worldly affairs

with his supernaturally spiritual. It is such neglect of man's life in the four relationships (man-himself, man-God, man-universe and man-other humans) that has led to a Persian saying, "Ever since he broke up with his dear aunt, he's been thinking about  
".conquering India

Will Durant's mistake in interpreting Ghandi's attempt to liberate India was ignoring the fact that managing all the tedious social activities of negative resistance is impossible without knowing the principles of politics, even though the negative resistance against the enemy may be a religious and spiritual one; since moral, religious, political, legal and revolutions should be based on man's original needs, any constructive revolution must have been established on the basis of human spiritual motives. Hence, some sociological experts have stated that any change truly advantageous to humanity, must definitely arise from religious

### **The Essence of Life in Indian Culture**

Essentialism is quite common throughout Indian culture, although it is mostly based on emotions rather than reasonable deduction. With the exception of feeling the existence of God, its essence is the highest, most significant feeling of humans, especially because the higher the essence is, the more elegantly glorious it will be. However, there are several points of significance to be considered on this cultural  
:element

a. How valuable is well-reasoned life? Is life virtually so gloriously priceless that man  
?can do nothing but sacredly respect it

This is incorrect, for any living thing of any situation, does not necessarily possess highly valuable merits; even man, the most complete of all creatures, is at times so dangerously rotten that he is ready to destroy millions of lives -maybe even the whole

world –for just a few moments of his own pleasure. If man cannot justify bloodthirsty tyrants like Ghengiz Khan or Nero, he would find no other reality provable either. Has  
?God truly created such glorious value in life

Would a culture regarding life as so extremely valuable, allow a group of people claiming to be supporters of culture to slay human beings influenced by propaganda and politics, without confirming its lawful, critical necessity for life? In other words, despite having a strong element like essentialism of life, how does Indian culture

These statements contradict the following, for the former describe culture as an everlasting flow, whereas the subsequent state, “Anything

going on alongside with people is human culture. Human beings have unstable behaviour, which varies with time and location. Human societies and behaviour have constantly changed throughout history, and new findings and experiences have influenced man's behaviour. Likewise, man's experiences, culture and behaviour affect all social influences. Therefore, culture should be regarded as a part of our ”.man-made surroundings

As you see, besides contradictions in describing culture in stability or variation, considering human behaviour as original is also another one of the current superficial deductions of the text. Unfortunately, such anti-cultural imitations have spread out of Skinner and Watson’s(۱) works into other societies. As we have frequently repeated, .few parts of the humanities have escaped the destructive harm of behaviourism

## **Culture in African Encyclopaedias**

### **A. Kenya**

Culture is peoples' lifestyle used in a certain period of time in order to deal with social, political and economic challenges. Kenyan culture has originated from three native :communities

(The Cushites (the Buran, Somali and Randil tribes .۱

(The Nilotes (the Luvo, Kolenjin and Masabee tribes .۲

For example, each ethnical group tends to express respect for its own tribe's customs  
and traditions in affairs like marriage, food, manners and morality as the culture of

along a culture totally different from the Bushmans or other primitive tribes

In general, the definition may be stated as the capability of various tribes and  
communities to adapt oneself with public laws

The English-based definition moved on to –and even accepted by –Namibia or other  
African societies cannot convey the essence of “true culture” in these societies, as  
laws transferred to other countries are unable to meet their real legal needs.  
Therefore, it is added, “despite diverse cultures dominating the various ethnical  
groups and tribes existing in the country

If the imported culture exceeds the native in strength and executive quality, it would definitely dominate the country; however, the established ideals, beliefs and logical conscience-based ideologies are too strong to fail to resist foreign cultures

### C. Other African Countries

By referring to expert research on African societies, we can address culture in other countries in Africa. Uli Bayer, for instance, has presented highly significant material

Delicate philosophical thoughts and highly religious beliefs have always existed“ beside simple-minded superstitions in legends; they resemble a huge ore of coal, containing randomly distributed lodes of diamond Therefore, unless we do not extract them out of the fairy tales through analysis of the legend and divide them into primitive thought groups, we

may never be able to discover the essence hidden inside delicate human thoughts and legends

As a matter of fact besides the playful lullaby-like aspect of legends and fairy tales, it is the existence of the most original resources of human thought belonging to various peoples in them that make researchers of philosophical thought, development history, upholders of human conscience, anthropologists, sociologists, theologians comparing different religions, ideologists and other scholars of the humanities and [folklore literature inevitably attracted to them.”](#)

The significant point about culture in African countries is that, unlike other continents where political, economical, legal and cultural changes happen gradually, highly intense changes in Africa have since the earliest times defied the usual process, turning primitively virtual culture into a complicated network dominated by technology

Clearly, African countries have suffered two kinds of cultural invasions, which can be categorized according to social and cultural lifestyles



;the culture of the invading societies

.generally mechanistic culture, relatively close to their national culture

The rise of religious cultures like Islam and Christianity in Africa has, of course, familiarized them with spiritual cultures which aid them to live by principles common in .other main cultures of the world

The first statement – “(seldom used to convey) agriculture or planting several shrubs” is quite significant, for it requires the Latin meaning of culture {agriculture and other pertaining meanings to it) which later infiltrated into most European dictionaries and encyclopaedias to have been the oldest one, which has been cited by the authors as a reminder alongside the newer meanings, Since the attention to the archaic quality of agriculture as a meaning of culture has been fading away in Finnish and other encyclopaedias and even in conversation the question is why the French Encyclopaedia has cited planting (wheat) and fertilizing the soil as the primary ?meaning

### Culture in Swedish Encyclopaedias

Culture agriculture; originally, cultivating the earth. More general meaning, all human activities, also results of spiritual and physical activities passed on to the next generations, The more common meaning of culture is spiritual development in fields like knowledge, literature, arts and religion. In archaeology, culture pertains to the (remains of a certain geographical location at a given point of time.”)

Again, as in the previous definitions, the evolutionary, virtual quality of the vital phenomenon, culture, has been conveyed through listing some of its effects: “spiritual development in fields like knowledge, literature, arts and religion”, for they are –and .will always be –undoubtedly the highest ways to human evolution

In philosophy, culture traditionally pertains to individuals, representing man's objective activities concerning himself, his environment, self-enhancement and .attaining the highest moral virtues

Sociologically speaking, man is part of a whole. Therefore, the term “culture” should be considered in association with society .Thus, the definition for culture would be: the vast and complex series of knowledge, ideologies, arts, morals, traditions or any capability acquired by man as a member of society.<sup>(1)</sup>

Sociology basically draws a line between physical and non-physical culture. Furthermore, it tries to combine culture with society, since it considers all human phenomena to be dependent upon social culture. Thus, social roles are to some extent determined by culture. In philosophy, culture traditionally pertains to individuals, representing man's“ .ε  
objective activities concerning himself, his environment, self- enhancement and  
”.attaining the highest moral virtues

This statement obviously approves that culture is an objective human activity  
pertaining to man's own self, his peers, his environment and also his self-  
development aiming for the highest spiritual virtues, clearly an evolutionary  
.phenomenon

The sociological claim, “Man is part of a whole.....” is absolutely correct, and in .ζ  
approval of almost every encyclopaedia published by civilized countries all around the  
.world

Sociology...tries to combine culture with society, considering the fact that all“ .η  
”.human phenomena are dependent upon social culture

The point here is that, if human development

and evolution had been followed as a principle throughout history, philosophical and sociological approaches would have enhanced each other, rather than fall separate

One of the final statements reads, “when we speak of 'high and low' culture, we actually mean how close people's culture is to ۱۸th and ۱۹th century European and American culture”.

The author(s) have astonishingly based the criterion for high or low culture on ۱۸th and ۱۹th century cultures of Europe and America, whereas other societies, e.g. Eastern countries, possess cultures much better established, more delicate and more evolutionary

### **Culture Seen in Turkish Reference Books**

Culture is consisted of a nation's way of thought and works of art resulted in by“ imitation, criticism and experiences acquired throughout life; any lifestyle caused by connecting thoughts with hearing; improving thought levels and standards of social life through criticism, appreciation, comparison and gathering necessary information”.

The significant point in these statements is, “improving the level of thought and standards of social life through Criticism, appreciation, Culture is, of course, a factor in improving thoughts and social lifestyles. The point lacking attention here is the evolutionary aspect of culture, which has been emphasized by almost all distinguished encyclopaedias around the world

The word “culture” found its way into the Turkish language from French and Latin“ after young Turks came to office in ۱۹۱۰, when Mustapha Kamal began vast cultural changes; it generally means civilizations remaining from the past. Its other meanings are

:World Treaty on Human Rights as

Article 10.27: Every human being is entitled to the right to live freely, contribute to his  
society's cultural lifestyle, and enjoy its scientific and artistic advantages. Everyone  
has the right to be provided with material and moral support caused by scientific  
.endeavours or literary and artistic works

This right has been further emphasized in the Treaty of Economic, Social and Cultural  
.Rights

Article 10.51: All member countries of this treaty are in official agreement on these  
:rights for every human being

;a. to contribute to cultural life

;b. to use the advantages of scientific advances and its applications

c. to be physically and morally supported for one's scientific literary or artistic  
.accomplishments

Article 20.15: Members of this treaty are to play an active role towards the achievement  
.of these ends by means of developing science and culture

Article 30.15: Members of this treaty totally agree on the right of free research in

.scientific and creative domains

Article ۴۰.۱۵: All members of the treaty acknowledge the necessity of international cooperation towards scientific and cultural development

Defending human rights against racial injustices in cultural issues has been emphasized in this treaty

Article ۵: In accordance with the fundamental rights stated in Article ۲ of this treaty, all members pledge to prevent any

kind of racial injustice –whether in race, skin colour, nationality or ethnic group –so that any human being can enjoy equal rights, especially in

a. economics, particularly social and cultural rights

As beauty has a virtually external aspect, such as the refreshing appearances of a flower, moonlight, a river fall, or beautiful handwriting, so does culture, like observable examples of morals, works of art, and architectural characteristics  
.representing various external acquisitions and ideals

The most apparent evidence for the bi-polar quality of culture is the same as that of beauty, which is specifically devoting the capability of comprehending beauty to man. In other words, cultural life is exclusive to human beings. If we consider all of the  
.given definitions for culture, we find that none are applicable to animals

Human perception and activities are undoubtedly unlimited from an evolutionary

point of view. Man's experiences throughout history obviously prove that although no human being can innately achieve the essence of greatness, moving on a path towards the highest virtues is nevertheless a characteristic of mankind which has caused his immense accomplishments and all well-established encyclopaedias around the world approve of

Hence, those activities and phenomena not rising from mental and psychological processes cannot fit in the definition of culture, no matter how appealingly fantastic they may

be. Even if interesting issues play a role in preventing life from becoming monotonous and fading the boundary between physical and spiritual affairs, they should nevertheless be excluded from culture –for the sake of the essence of culture itself let alone when they are harmful, e.g. obscene pictures which demolish moral chastity, or some types of music and drugs

Unfortunately, fallacious paralogism has brought about deviations in the highly virtual meaning of culture, degrading it to a level which ranks humans with lowly animals, like gathering many huge snakes intrigued to bite; as ancient Persian culture states

This is the natural ego observed in man throughout history

Can brotherhood, equality, reasonable liberty, graciousness, and human dignity be achieved through such natural egos so deeply immersed in conflicting disturbance?

.By no means, for such a wish would prove only a humiliatingly deceitful hallucination

Therefore, accomplishing high virtues such as unity, logical equality and brotherhood in human societies inevitably requires perfect cultural elements like proper, meritorious morals and the highest qualities, such as justice, dutifulness, sympathy towards

peers, accountability towards other fellow citizens and conceiving the exquisite glory of the universe by comprehending its beauty and fine order, all of which guide man along the quickest possible way to the creator of the rules of equality among men. No other path would lead to the pure ideal depicted by Universal Human Rights, man's general culture, morals and human universal nature

Nowadays, scientists, experts and anyone with the least basic knowledge can merely refer to any well-known encyclopaedia to realize the essence of a culture able to save humanity, which can be defined as

The proper quality or deserved methods used for those of man's physical or spiritual needs based on human logical thoughts and emotions arisen from reasonable evolutionary lifestyles

This is a fundamental part of our discussions on culture. In other words, by presenting the definitions of culture in various well-known encyclopaedias all over the world, we prove –at this critical period of time –that the commonalties between them all are properness, perfection, physical and spiritual development, graciousness, dignity, integrity, meritorious life, responsible freedom, and lawful justice

Now let us analyze the above mentioned definition(۱) that we stated as the most comprehensive of all. Doing so, we will come to four main principles vital to achieving the important ends and content of culture

### **The Four Principles of Culture**

ONE: The concept of culture –as presented in civilized nations –include “proper-ness” and “deservingness” based upon the logical thoughts and emotions arisen from

This is why no aspect of selfishness (racism, greed for money, power, fame or pleasure) can fit into the concept of culture, for as we quoted from the world's most distinguished .encyclopaedias

Culture is the proper quality or deserved method of the phenomena in man's life; in“  
” .other words, culture contains the highest values

Thus, those who call greed for fame, money, power, pleasure, selfishness or mutiny culture, have betrayed the highest of human virtues terribly. Calling a person or a .society cultureless is the worst insult possible

TWO: Without culture as we defined it, human life does not deserve to go on, for a life without culture means a life empty of meaning, thought, logic or perfect human .emotions

THREE: The more the culture of a society depends on logical principles and high .human receptions, the more meritorious and proper it will be

FOUR: Culture is a two-dimensional reality, consisting of absolute and relative .aspects

Clearly, by “absolute” we do not mean in the philosophical sense, but that it is much more comprehensive than other relative cultural elements. Such a categorization .brings us to general and special cultures

Special cultures, caused by the relative aspect of culture, pertain to certain nations or

peoples of specific thoughts or emotions. A few notable examples are the cultures

of bullfighting in Spain, or the exaggerated amount of courtesy and bowing in [Japan](#).

General culture pertains to meritorious qualities appropriate to man's physical or spiritual lifestyle, phenomena and activities not limited to any specific nation or race, e.g. cultures like aesthetics, mutual respect among people, justice, knowledge, and .creating heroes

We may conclude from the above statements that, since culture means the proper qualities fit for the physical or spiritual phenomena and activities in man's life, accepting and reflecting the totally natural compulsory facts or effects of human life such as eating and drinking cannot be regarded as a part of culture; however, their connection to prayers, which is quite common in Islam and some other religious societies, fits into the domain of culture. Defending one's life, preparing a shelter, or accessing scientific or philosophical facts through the senses can also be considered .as a part of culture

### **The Connection between the Necessary Cultural Elements and the Merited**

It is quite difficult to make a clear distinction between these two types of cultural elements without encountering a conflict, for accusing man of ignoring the gloriously perfect human ideals for providing the necessities of his life, would be denying the .most obvious of fact –all reason and conscience

Defying human glory and man's great ideals, and degrading mankind down to being equivalent to honeybees, means destroying all humanity. Furthermore, isolating cultural concepts from the vital facts of life –like knowledge, science and other mental activities that adjust or life –leads to the separation of perfectionist tendencies from ,normal life

Such inordinate cultures –like other special cultural elements and phenomena –are – 1  
.heading for demise, except for principle–based cultural aspects  
which in turn causes spiritual dilemma between “natural and evolutionarily spiritual”  
.life

Early in the 21st century, we have seen many pioneer societies on the earth making  
great effort in order to implement the most realistic economic, social, legal or moral  
ideologies in their communities. Not only did they fail to do so, but they have even –as  
we have already seen in the definitions of culture in such countries as Russia or China  
clearly admitted the necessity of a pioneer spiritual culture regardless of any  
.presumptions of an ideology

Accepting the necessity of culture is not brought about by one or a few conventional  
factors, but by man's human nature, without man would totally lose his humanity  
when “man stepped which out of his prehistoric caves and entered the unfeeling  
”.wheels of a machine

Hence, ever since man came to being, he had culture beside him to provide his life

has given profound cultural value to morals and arts (in a general sense), true  
knowledge, “taboo morals”, customs and even laws. It is quite a simple,

We can generalize the same moral expectations we consider for man to"  
governments, rulers, parliaments and political parties. If politics does not have a  
moral basis, there will truly be no future for mankind. Russians

deepest emotions concerning “what should be done”, c) freedom –in the sense of having the power of choice, which arises in actively powerful qualities during evolution, and d) religion, addressing questions such as: “Who am I? Where have I

After seventy years of unbelievable pressure and suffocating dictatorship, there is now abundant freedom among the poor classes, and many people have totally forsaken their conscience; however, we must not let this problem distribute among other countries. As we approach the end of the second millennium, this problem

### **The Progress Crisis**

:He adds

We do make progress –but in what? What kind of advances are the issue here?”  
Progress is limited to technological civilization, more luxury in life and military explorations. We are voraciously swallowing the nature that we take for granted. But among such progress –devoid of any moral development –our physical needs increase  
.with such extreme rapidity that we are left confused

We insatiably keep expanding our possessions (in other words, we more and more use up our resources of human identity); however, when it comes to acquiring higher moral virtues and spiritual goals, we prove to be futile tools of greedy exploitations. Transportation and communications now take place at incredible ease; people can  
.travel all around the world with a mere pressing of a television button

Yet, in the middle of such an ocean of superficial information, the human soul is not only failing to progress, but is actually heading for doom. The more materialistically luxurious man becomes, the more will his spiritual life fade away. Scientific,



technological, and economic advances are leading

us to slavery. Constantly in seek of new discoveries, we have lost our goals; what indeed, is the end in life? We failed to escape from our endless responsibilities

Telephones and television demolished the integrity of our time, and began to impose the conditions upon us. Communication among humans began to frail. People, particularly the elderly, found themselves living alone. Unable to put technology to use in welfare aims or to unite humans, we have become its plaything. Progress couldn't keep us away from globalizing responsibilities. Furthermore, we are increasingly unprepared for them

We have lost the rhythm that was always alongside our virtual and physical well-being; good and evil have become illusively obscured. Another outcome of our spiritual degradation is the absence of the relaxed attitude we used to have towards death

However financially secure one may be, the fear of death starts a cold sweat on any tycoon's skin. Insatiable, scandalous lifestyles have brought about an immense horror of death. As man gradually tries to consider himself the center of the universe, he tends to see the universe as a part of himself, rather than see himself as a part of the universe

The presumption "Everything leads to death" has begun to dominate us like a threatening weapon. Nuclear threats rule the Twentieth century. Although everything seemed indifferent afterwards, the threat created a uniting concept in order to impose itself again on Western societies. Towards the end of the century, internal ideological decay caused Communism to self-destruct. The

demise of Communism caused the nuclear threat to recede, at an unpredictably rapid rate. The world, however, still does not feel completely secure

Communism still lives on in Some parts of the former Soviet Union, for as brutal capitalism continues to disgustingly ravage its national resources –to such an extent that even has the West astonished –Communist slogans on 'equality and justice in (poverty , have appealed to classes unable to withstand the conditions” (1

### **?Has the Reality Called Culture Undergone Evolution throughout Historic Changes**

Progress in several cultural elements, such as science, cultivating talents and potentials, usually responds with a positive answer: Yes, culture has evolved throughout history, Of course, evolutionary progress in culture is any perfectionist ?human being's ideal. But does history also confirm such progress

If development means scientific advances concerning nature and human lifestyles, such culture has definitely made profound progress. The reason is quite obvious: the vital needs of life in nature, and also man's greed and ambition for power, has greatly .expanded the necessary phenomena of culture

We have already noted in our definition of culture that the necessities and worthy aspects of cultures do not always necessarily arise from reality, for man has time and again created artificial demands out of his selfish greed for power, and labelled them the necessities of life. For instance, exploitations, weakening peoples' will power and .various sexual intrigues have been called art, considered a meritorious culture

However, the other aspect of culture –including man's evolutionary needs for perfection –despite an ideal to any clear conscience, has not only

failed to progress, but even shrunk due to advances in man's necessities for natural life (i.e., physical culture), to such an extent that it is sometimes considered as a disturbing factor. Let us consider the reasons why physical culture has made so much progress, but evolutionary culture heads for deterioration (of course, we do not :(intend to deny any exceptional cases

۱. Inability in finding a culture that can moderate selfishness and protect and follow evolutionary virtues

۲. Affections that lead to positive virtues vanish due to the ignorance of cultures receiving reasonable and observable beauty

۳. Neglecting cultures concerning rights, power and how to use power in order to uphold righteousness

۴. Ignoring the culture of benefiting from outstanding figures and genius among the society

۵. Greed for power, fame and wealth has demolished man's culture of scientific conscience, except for a painfully meagre minority in which it has been confined inside their pure souls

۶. What on earth happened to the constructive culture that could elevate human relationships from a hide-and-seek charade to an ocean of pure souls where waves constantly meet?

toil and sacrifice put into making fundamentals –like a) meritorious life, b) human grace and dignity. c) reasonable. responsible freedom and d) total equality towards laws – a reality, not only puppet rulers today still unconsciously do obey powerful tyrants totally ignorant of humanity, but philosophical cultures such as Machiavellian’s doctrines on survival and the theories of authoritarians like Hobbes or Nitché are even .taught at universities without the least criticism

There are dozens of other examples verifying evolutionary meritorious cultures being .are ignored by the majority of today's human society

Among the worst effects of the decline in meritorious evolutionary cultures on man's life was his deprivation of acquiring higher virtual truth, which led to committing any kind of injustice. As a result, their perception of reality has become extremely limited. :Let us consider an example of such intense limitation

People have lost their ability to comprehend mental reasonable beauties. Mechanized life culture prevented man from understanding the beauty lying in the universe and in the essence of life. In other words, man is now only capable of sensing the beauty of a flower (an observable beauty) –that is how painfully degraded mechanized life has .made him

Thus, the beauty

of realities such as justice, righteousness, freedom of conscience, human dignity and .chastity and the essence of life remain buried in books of sermons

Various greed–driven crimes defying all morals and conscience, especially in political .cultures, have caused irreversible damage to evolutionary culture

The changes occurring in the logics behind human socioeconomic trends –shifting towards increasingly consumerist societies requiring more and more manufacture – has demolished the culture of “earn to live”, which leads us to “live to provide the :desires of the greedy” culture

In today's technological circumstances, the motto has become: More Production, “  
”!Better Economy

Do they really not know –or do they consciously ignore –who is actually responsible for more production? Are they unaware of those trampled under the pressure of manufacture increases? They do not seem to realize at all that however plentiful the  
.mines and resources on earth may be, they will eventually run out

Racism and regionalism are other “meritorious evolutionary anti-cultures” that are rapidly strengthening along with the “development of today's civilizations”. In fact, unlike many short-living socioeconomic theories and schools of thought, racism and regionalism are rooting stronger day by day, putting all laws, cultures, knowledge,  
.economics and universal human power up to ridicule

### **Disharmonious Cultural Elements in Real Facts May Demolish All of Human Culture**

We have already mentioned that since man is directly involved in the formation of culture –it is man who builds up a culture out of his environment, historical phenomena, relative and/or absolute ideals and his concept of ideology, and also it is  
man who attempts to harmonize permanent

laws with temporary events in a period of time in order to create a culture he could live by, and finally because man has too many aspects to harmonize –cultural elements usually suffer from disharmony, and ruling authorities prefer accountable  
.”“things” rather than “people

The primary reason for such disharmony is the authoritarian and power-greedy tendencies that prefer cultural elements directly or indirectly effective in enhancing domination and power. Thus, there would be no need for any organized system of  
.social culture

In other words, it is possible to have a moral culture based on emotions and still base scientific culture on purely mental anthropology .Like-wise, having abstract

tendencies in ethical artistic cultures, and yet seeing observable tendencies in its historical culture is also possible. Or maybe a purely supernatural religious culture beside a totally realistic scientific culture, e.g. European Christianity during the last two centuries compared to their scientific realism

The reason behind the destructive effect of disharmony of cultural elements upon the entire Islamic culture lies in the unity of human life, primarily based on “man's evolutionary virtues.” When basic cultural elements fail, unity vanishes and all of human culture faces certain doom. The most harmful form of disharmony in cultural elements is the isolation of spiritual basics and mental human virtues from physical aspects of culture, which is a result of greed for wealth, power and purely animal-like desires

Here is an excerpt from a paper by Paul G. Bahanan, anthropology professor at the University of California

cultures undergo change, some slowly and some rapidly. Since culture consists of various factors. Changes in one of them would also affect the others. Some sociologists believe that many social problems are due to disharmonious changes in cultural elements. Cultural retardation occurs when some parts of a culture tend to follow others. Many cultural retardation in the history of the United States have occurred in its non-physical traditions, thoughts and issues. Science and technology advance so rapidly that they have put spiritual issues way behind

### **Reasons for Disharmony in Social Cultural Elements**

:The main reasons citable for disharmony in the cultural elements of a society are

Selfish rulers: No meritorious reality in the world has survived destructive influences .by the selfish

When people believe that “law” is a spider web aimed to entrap the meek, culture will indeed be regarded as devoid of any worthy qualities of life or compulsory guidelines

Hedonism, which arises with “the natural self” and strengthens with nihilism, and .۲  
.defies all laws and principles

Authoritarianism, in any form or caused by anyone it may be, demolishes all cultural .۳  
merits, and so cleverly decorates their remains that it seems to claim, “I have granted  
you the most desirable culture you could imagine!” Poor simpletons who never cease  
.to be deceived time and again by jargon like cultural or civilizational transfer

### **Pursuant Culture and Pioneer Culture**

Pursuant culture refers to physical or non-physical qualities and ways of life based on“  
”no pre-established principle, but seeking approval only through people's desires

In other words, such cultures arise from any need, behaviour or desire people have,  
.regardless of their compliance with man's non-physical realities

Thus any of people's desires opposing religion, morals, dignity or logic can be  
considered as culture! Such Fraudulence in the name of culture(۱) has greatly spread  
.during our times, and will undoubtedly lead to the annihilation of humanity

Although pursuant culture obviously means obeying human desires, we must keep in mind that it also provides selfish authoritarians with the chance they need

In fact, this kind of culture both satisfies people's purely natural desires, and those of their rulers, who find the opportunity to not only fulfil their people's wishes, but also disguise any factors opposing religion, morals or human dignity in the name of culture

Pursuant laws could prove to be much more suitable for people's needs rather than pursuant culture, for "laws" pertain directly to the context of people's lifelines, which thus can be constantly modified and adjusted according to people's actual needs; culture, on the other hand, being based on non-physical beauties and delicacies, cannot be

At times, these selfish impostors even have their intellectual-looking directors add the term "free" to culture in order to optimize its deceiving affects: 'free culture manipulated by people's physical needs. However, any lowly, morality-defying activity or quality is nowadays publicized in the name of culture

Considering this theory proposed by several sociologists, we may come to the conclusion that a constructive, pioneer culture as the leader of human civilization should be a doctor, not a waiter

Doctors are highly different from waiters, Waiters in a restaurant provide you with whatever you desire, whereas a doctor follows his own academic principles; he prescribes what he believes necessary, regardless of what you think, A pioneer politician should be like a doctor, not a waiter

### **Whenever Man Has Followed Pioneer Systems, He Has Successfully Made Progress**

:Let us present a few examples to elaborate on this critical point

a. Is it possible for an ordinary person to interfere in the most advanced of academic



?issues merely by having freedom and pursuant culture

b. Can the medical practice allow an uneducated person to examine and cure sick  
?people only on premises of freedom and pursuant culture

c. Can we possibly let anyone enter an operation room and, relying simply on freedom  
?and culture, begin to cut up people's bodies

d. Is it possible to conceive someone stepping into a gun factory and start to comment  
on everything, and meddle with any tool he wishes, on the basis that, "I am making  
use of freedom and pursuant culture, of course? The times when people were  
deprived of freedom and their desired culture are over. Decadence is forbidden all  
"!over the world

e. Will there ever be a day when anyone would

comment on any scientific or technological matter he wished, and if told, "you are not  
educated in such issues, so you should not meddle or interfere", he would retort, "Yes,  
I am entitled to use my own culture and freedom, for the age of decadent deceptions  
"!and forcing people to imprison their thoughts are over

f. Culture and freedom are indeed amazing. Consider someone whimsically wearing a  
decorated military uniform. If he faces protest, can he claim, "Down with the anti-  
"!Liberty! Down with the anti-culture

Obviously, all of the above-mentioned who carry the book entitled Freedom(1) should  
.be taken to mental asylums

Now we can move on to the main point: whenever man has considered an issue  
essential to his survival, he has applied pioneer principles –sciences concerning  
human relationships, managing labourers to one's own advantage, social leadership,  
political activities and employing cultures for specific purposes, medicine, surgery,  
lethal arms and armour and military propaganda –quite successfully, though man's

.intrinsic progress calls for the truths about his perfectionist growth

Hence, all the cries for freedom, free pursuant culture and free art! And humanity was degraded back to even before prehistoric ages. The reason why is that cavemen had not confined their potential for progress to their own selfish desires, and had –  
.consciously or unconsciously – begun to activate their talents

Here are a few examples of the culture of facts demolished in many societies –not because they failed to resist and satisfy man's evolution, but due to selfish rulers making

Out statement, “Whenever man has followed pioneer systems, he has successfully achieved progress” does not imply that man can evolve progressively by abstracting and adjusting a group of key issues called laws; we mean to state that throughout history, whenever man has made and obeyed laws based on well-prepared information –without the influence of public desires –he has made successful evolution. Thus, in issues concerning science, technology and any matters benefiting man's physical needs or selfish desires, we see man successfully using pioneer culture, whereas in evolving the essence of man –which involves religion and morals – he has totally ignored pioneer culture, and followed cultural phenomena in the name  
”.of “following free culture

### **:Cultures Can Be Categorized into Four Main Groups**

Sedimentary culture: In this form of culture, fixed laws based on ethic, mental, geographical and historical factors form totally unchangeable lifestyles and guidelines which can destroy or adapt other changes to their own advantage. If non human and non-natural factors cause a sedimentary culture, compulsory environmental factors or the people's psychological in capabilities to adjust to positive changes may lead to  
.useless insisting on ‘self’-orientated activities

Colourless liquid” culture refers to deceptions and explanations based on no“ ٢

fundamental, psychological roots, which are hence constantly variable. Societies possessing a history, of course, seldom seem “colourlessly liquid”, for as we have already seen, cultural ism originates from a basically active psychological source

Any society throughout history tends naturally to pass its concepts and guidelines in life on to its next generations, and while this phenomenon –or better said, psychological factor –remains, the culture will also keep its stability in a number of activities and effects

:Thus we now come to two points

a. As we have already mentioned in our discussion on Cultural Disharmony and Its Reasons,<sup>(1)</sup> there is no logical need for the cultural elements of a society to be harmoniously related; therefore, some elements may be “liquid,” rootless and highly change-prone, while others are stable and well-established. In some Arab societies, for instance, stable moral cultures accompany fervid changes in political cultures

b. Despite being a relatively stable phenomenon, and however constructive a culture may usually be, when based on Machiavellian rules of social life management, they will fade

away. We also know that despite all of the immense advances man has made, he is becoming increasingly powerless in distinguishing “means and ends”, particularly in societies incapable of managing human power; in such societies, power dominates people, and their essential culture destroys any principle or culture aiding them to achieve their goals

Self-orientated culture (pursuant self-orientated): In this kind of culture, activities and effects that interpret cultural facts are essentially the desired ones, and completely quench cultural ideals. Such “self –orientation” specifically pertains to ١٩th

.and ۲۰th – century scientific, technological and economic cultures

The self-orientated” inhibits the main identity of culture, which is creativity and “developing the ideals of the “human self” in various aspects of life. The other effect of “self-orientated” culture –which is by no means less dangerous than the first – is changing man from the creator of science and technology to a helpless part of them.

.We should keep in mind that when one or several aspects of human life

For example, the art of make-up –turns “self-orientated”, it would become unable to satisfy other culture-seeking aspects –e.g., the desire for truth. Therefore, duality in character arises; the ego partly mixed with the effect (in this case make-up techniques) dissolves in it, for it has turned “self-orientated”, and the other, seeing the rest of the human culture-seeking aspects fade away, gradually disappears, and the whole character is engulfed by the original effect

Fortunately, observations show that not many people are obsessed by “self-orientated” influences

so there are always people conscious enough to condemn other's infatuation by some qualities in life or the weakening of other human culture-seeking aspects. Alexis Carrel in ۲۰th century France, Thomas Eliot in England and William James in America – and also many other scholars from all over the world –have openly denounced such .Internal captivities

This kind of culture is not affected by activities susceptible to the variables and unstable aspects of life, for it is caused by permanent natural facts and originally human aspects, and aims for the relative ideals guiding man towards the highest goal in life. In fact, this is definitely the human culture that is essential to any human civilization throughout history. This is the culture that can free itself from greedy, selfish rulers and continue serving the society

Its other quality is its ability to neutralize morals and traditions based on imperfect thoughts, efforts to fill the realistic gaps of life, and in general, all unstably regional factors devoid of authentic ideals

By further studying creative, objective and pioneer cultures, we understand why many other human cultures have diminished. The main reason is the sedimentary activities caused by the deterioration of their creators, or “self-orientated” cultures in which man imprisons himself instead of any analyzing and explaining his activities.

Therefore, even if the cultural results they cause are able to survive, they will gradually turn taboo, and disappear from the horizon of the society

### **?What Causes an Objective Pioneer Culture**

We must first bring back to mind the culture-seeking factor cited in the four definitions before addressing the roots of objective

The general history of mankind, scientific evidence and philosophical experiences all prove that man cannot remain satisfied with his compulsory natural and biological qualities (as bees or ants do), and when his basic physical needs have been provided, he will strive to know the “hows and whys” of nature, turning his whole environment upside down to find his answers; and since his sensory, logical and mental viewpoints  
”?are unlimited, after achieving each goal he asks himself, “Now what

Taking such adventurous, insatiable behaviour towards various situations into close consideration brings us to a basic reason (or reasons), without which we would never be able to comprehend the motives behind objective –or even other –cultures. It would be impossible to find out the factors causing the rise, climax, demise, fall, or even transfer of cultures between societies without taking the roots of culture-seeking into consideration. Likewise, we would not be able to achieve a pioneer,  
.objective culture

:Human culture-seeking appears to be based on primary and secondary factors

THE FIRST ROOT is the active psychological factor arousing man to build and arrange his natural, physical surroundings and adjust the unchangeable phenomena around

.him in a way appropriate to his creative self

THE SECOND ROOT refers to internal and external factors belonging to specific countries or peoples which determines the former root, and explains their modes of .life

Considering the first –and primary –root of culture– seeking, we may conclude that cultural diversity is as numerous as those of human aspects

aiding man to adjust and change the world according to his ideals. However, we have already seen that man is not capable of building a perfect culture that would satisfy all of his various aspects; he cannot accumulate and organize all different cultural components. Unfortunately, every civilization throughout history has had to suffer .such failures

The reason for the above-mentioned inability is not due to negligence or uncontrollable inhibitions blocking the culture-makers way, but lack of attention to the active psychological factor aiming to both build a suitable home out of natural, unchangeable processes, and cause positive changes. On the other hand, we should remember that confining a society to –for instance –its ancient monuments, does not suit today's dynamic trends. Also, how can a bundle of taboo behaviours established ages ago – with or without good reason –be able to satisfy today's highly developed man? Indeed, such arts, morals, beliefs and lifestyles can play an active role in today's .culture in two ways

.First: Their general social and/or psychological impact– if they have caused any

Second: Historical application and understanding how lifestyles of the past were colored by those cultural affects, and also how the society found its definite path, the .perfect “home” its people had made

In order to have an authentically original culture; we must relate all of our ideal activities and/or outcomes to the active psychological factor, which –although stably



creative- can provide them all. It would prove totally infertile, however, without being saturated with the

.We had better now elaborate briefly on the clear aspect of culture

### **Culture's Clear and Observable Aspects**

The observable aspect of culture refers to those ideas, ideals and accounts of life materialized by visible effects in our world, e.g. works of art, moral ethics or technology supplying our requirements

The clear aspect of culture depicts the ideals, emotions, morals and goals chosen for man's life, which – consciously or unconsciously –account for his individual or social lifestyle. They are “clear”, which means they have no visibly observable aspect. For instance, when a French historian writes about Napoleon Bonaparte from a clearly racist point of view, he would definitely call him the greatest hero of all time, as an Iranian racist historian would do so with Xerxes in a clearly racist approach

Assessing The History of Gibbon on the rise and fall of the Roman Empire, Whitehead :also believes that

Gibbon has produced a successful account of history, albeit from a totally ١٩th century point of view

Ever since the eighteenth century, the scientific aspect of culture has in two ways :brought about the current situation in the West through intensive brainwashing

First: an incredible, human reality –the eagerness for discovering facts –that has been a human ideal ever since the earliest times: science. As it provides men contact with facts, science is considered a critical virtue of life, thus engulfing all mental endeavours around the world

Second: science gave birth to technology, which caused

great luxury in people's lives. Societies where technology was developing became so fascinated with its economical and prestigious advantages that, not only did they totally forget humanity and a deserved human life, they even made science a slave of its own creation, technology –“scientific bankruptcy”[\(1\)](#) arose, and logical human virtues were totally ignored. A clear aspect of “We are the highest race” and “We are Pioneers of Human Development” was engraved in their minds! It is now still spreading at full strength

The unbelievable result is, the motto “I have technology, so I am the greatest on earth; I own everything all over the world, which I may use at will

This, indeed, is the culture that is gradually destroying original, worthy cultures of different peoples, and has clearly turned into an anti-culture

The great cultural aspects that have been sacrificed by the clear “We are the greatest” aspect are: the highest of human emotions, a broad scope of life, the high aim of life, sympathy, and balancing powers and privileges to man's benefit. It has revived the fight for survival, which thousands of prophets, wise men, philosophers [\(2\)](#) and any other human-loving person all around the world tried so hard to uproot![\(3\)](#)

### Various Clear Aspects of Culture

The clear, unobservable aspects of culture –which account for its observable ones – differ widely in nature, range and activity

The nature of some clear aspects of culture –which can also explain its visible aspects –arise from natural human qualities, like selfishness, greed for power, etc, each

You may have heard Ernest Renan's idea, "The West is the employer race, and the –2 East the employee. That is why nature produces a larger amount of labour force!" See how this so-called "intellectual" ruthlessly insults nature. Mr. Renan apparently knows nothing about Eastern civilizations, the true creators of science and technology. He adds, "The Western mind is industrial, official and civilizational, whereas that of the Eastern is emotional mediocre, and lacking for today's high thoughts!" It is quite surprising how such a "scholar" can be so ignorant of Eastern civilization history, and that the human brain has not changed in any race for at least 40,000 years. Most astonishing of all, he didn't even try to reason inductively that most inventions have .also been achieved by accident, not accurate calculations

of which vary greatly in form and approach. Since they are human-originated their range is much stronger and greater, or as Thomas Hobbes claims, "Man can attack man like a wolf." We must keep in mind, however, that all conscious individuals or communities aware of humanitarian sacrifices made in benefit of human justice and emotion throughout history, not only do not admit being affected by –and accepting – ".selfish and power-greedy aspects, they even pretend to be against them

Racism and inadvertent patriotism, (in any way, not illogical patriotism) is another .2 clear aspect of culture that is –consciously or unconsciously – influencing other "aspects

General ideals all well-balanced humans have agreed on throughout history, such .3 .as science, arts, civilization, health care, etc

These clear aspects, if activated without being contaminated by selfishness or ambitiousness, can be –in their true nature –extremely useful. But unfortunately, as we have already mentioned, they have caused sidekicks which have totally .demolished their creators' good name

Saving ourselves from such clear aspects –which first entice us with their attractive appearances, and then turn into oceans of selfishness and greed to drown us –is only .possible through determining the greatest of goals in life and adhering to them

## How to Improve the Clear Aspects of Culture

Although the simplest and most straightforward, the way to improve the clear aspects of culture is also in the most exclusive and essential one proposed by wise intellectuals. It is, however, the longest and most complicated, too

The most direct, simplest, and still the longest and most

complex way is for man to return to himself; today's man has fallen greatly astray from his own self

Clear aspects, of culture interpreting and explaining all cultural effects and activities are like glasses with colored lenses, changing man's viewpoint of his life. These aspects of life can undoubtedly give no pure reflection of man's observable world, for reflected observable phenomena cannot be more effective than their real image; purely imagining beauty is never as influential as seeing real, visible beauty. The imagination is only intrigued when the viewer wants to possess the beauty, or paint a picture of a beautiful phenomenon

Likewise, a mental image of freedom cannot be as intriguing as real freedom; it can only be effective when it proves its desirability to the imaginer

Therefore, we must distinguish clear aspects of culture from pure imagination; in order to do so, we have to consider the fact that clear aspects have the activating effect reflections and imaginations are devoid of. Besides, reflections and imaginations identically reflect what exists in the visible world –like a mirror –but they ignore their relationships with each other or basic goals fundamental factors; the clear aspect, however, accounts for all observable facts along with their connections with logical ends

Hence, all dimensions of life –pleasure, pain, knowledge, need, logic, imagination, morality, religious and ideological tendencies, artistic creativity, etc. are explained by the clear aspects of culture. If they are confined to facts formed by compulsory,

thoughtless activities, they would in fact only

.be reflections acting on naturally- originated factors

We may conclude that, in order to provide satisfactory answers to the “hows and whys” of life, the clear aspects of life should provide man's highest ideals in life. Thus, we can state that any culture unable to determine the highest aim of life, will also  
.definitely fail to provide its ideals

Without activating the constructive aspects of life, the highest aim of life would not be capable of being creative or dynamic. Any individual or society requires evolutionary goal-setting –whatever its cultural effects may be –in order to achieve an objective freedom which can ensure the survival of an original culture. In such cases, any cultural effect or activity would prove devoid of any saturation by idealism or providing a basis, like a heap of compulsory activities. Aimless works of art, despite being highly attractive and exquisite, can only motivate us momentarily, but they do not guide us after we are aroused. If we accept the necessity of objectivity in original cultures, the rigid traditionalism in some cultures would definitely turn into original,  
.constructive ones

Cultures move towards their goals just like souls do. In fact, the culture of a society depicts its soul, and all of its cultural activities and affects represent the attitude of its  
.spirit

Thus, the only way to create an original, objective culture is to enhance the emotions and thoughts of the members of the society, and make them so harmonious that each  
human being would freely

.be able to create his/her own desired culture

As we have already mentioned, without elevated goals, it is impossible to achieve true

freedom of character, otherwise the society would fall into “free” slovenly cultureless ness, which would shatter away when compared with other cultures. Now that we have realized the need for explaining and interpreting the highest reasons and goals of life, we should find an ideology capable of such interpretations vital for creating an .original, objective culture

Ever since earliest times, many ideologies have proposed various ideas on the highest aim of life; however, by studying them, we come to a universally agreed conclusion: “Any target is located higher than the one that is aiming at it.” Thus the aim of life must be much higher than the mortal phenomena and activities of everyday life in order to .provide a satisfactory explanation for the whole fundamentals of life

Tendencies to move towards higher goals will certainly prove incompatible with the rise or fall of some cultural effects and/or activities; furthermore, the cause-and-effect rule puts culture –the “effect” –into the right evolutionary course. Of course, there is great debate over what the great aim should be, and we do not tend to go .into its complicated details

With the exception of hedonists and nihilists, all schools of thought –as we have already mentioned –agree that “the target is always higher than one aiming at it.” Thus, no school of thought can present phenomenon or activities as the highest goal to

The most valuable and greatest quality of objective culture seeking an objective life is its logical organization of cultural elements –the highest human ideal. Objectiveness leads to cultural organization, as having an aim for one's soul causes mental order .and discipline

It should not be so surprising to us that cultural elements suffer from so great disorder in most human societies today, for philosophers and intellectuals have also for some time claimed to be unable to determine the true aim of life. After all, when the human spirit is mutilated by economists, lawyers, psychologists, expert sociologists and greedy technologists, how can we expect a culture with logically !?organized elements

All in all, we are left with no choice but to first solve the puzzle of the aim of life, and then move on to organizing the fundamentals and rules of a culture. Culture– maker today are

apparently obliged to consider the highest aim of life; otherwise, the way today's mechanical lifestyles and uncalculated civilizations are going on, they will undoubtedly .face nihilism

### **The Highest Aim of Life Makes Original, Objective Cultures**

No aim can suitably explain a certain period of human life –his lifetime –including all regional and social, factors depending on historical knowledge and human capabilities without addressing these four questions: Who am I? Who am I with? Where am I ?going to? Why am I here

By such questions, man undoubtedly intends to find out how he depends on his world. Now matter how his ideology may be, it is enough for man to have a world to be born .in, get familiar with, develop a passion for, and finally die

Without love to explain our relationships with the world we live in, there would never be any of the vast, fascinating cultures that have formed throughout history, nor any of the arts originating from man's far-reaching ambitions. Perfectionist, ambitious man, always reaching for higher positions –however highly accomplished his activities may be –can only be saturated by divine attractions –to which the only way of entrance is the human soul –unless, however, a cultural activity or effect is exaggerated and disguised so greatly that it would satisfy man's insatiable spirit. Such .cultures would prove alive, colourless, sedimentary and self-orientated

Considering our above discussions, we come to the conclusion that it is impossible to achieve a dynamic culture without religious and ideological factors caused by .objective life

By “ideological factors” we do not

mean a heap of illogical, unverifiable beliefs, but man's spiritual awareness moving on :the path of evolution towards divine attraction. As Iqbal Lahouri says

What is religion? Rising from the earth, to achieve self- awareness of the soul

Along such a path, the world has been resembled to man's precious body, full of both cultural results and activities to “decorate” the home. In fact, the precious “home” is the world inside the “self”, which will stay with us forever; it is not a place to stay for .some time and then leave

### **The Culture Established by Islam**

The culture established by Islam is an aimed life that strongly activates human aspects of aesthetism, desire for knowledge, logic, and idealism, and organizes all cultural elements. It does not isolate scientific culture from high human morals, does not separate artistic culture from the culture of economic guidance, and finally,



considers the unity of culture as a dependant upon unity in human souls, thus preventing its destruction. The elements of Islamic culture –referred to as “culture of the mind”, “qualities”, “science”, “morals” (literally) and “the best form of all affairs” in .major references –all belong to a high concept: wisdom and philosophy

This wisdom includes any kind of activity able to enhance objective lifestyles for each individual or society. The first founder and promoter of this culture is God, who granted man the means to write, talent, power to express

himself, taste, and the constant desire for seeking perfection and stable basics in the .ever flowing stream of events

:As a result of this culture

Three centuries after the Holy Prophet (s) died the city of Qartaba. with a population“ :of one million, had eighty academic schools and a library including ٦٠٠,٠٠٠ books

Arabic had become the main language of science. During this era, knowledge resumed spreading around the world. Zachariah Razi (٢٥١–٣١٣ AH) did a thorough study on smallpox, and his colleague Abul-Qassem Khalaf bin-Abbas Zahravi (d ٤٠٤ .AH) did the same for brain and spinal bone diseases

Avicenna (٣٧٠–٤٢٨ AH), named "the prince of science", had upgraded medicine in the Islamic society to such an extent that when one of the kings of Castill caught .smallpox, he asked his enemies in Qartaba for help

Mohammad ibn-Jaber-ibn Senan Battani (d ٣١٧ AH} has brought much honour to his country through his famous works. A noble aristocrat, Battani had great respect for Ptolemy, although he himself exceeded Ptolemy in accurately studying the equinox calendar, and was the first to use the sinus instead of the hypotenuse, which led to .(today’s trigonometry(1

Literary culture as a whole –the voice of any cultural ideal –became such a mighty

creative factor in Islamic societies that by presenting Jalaluddin Mowlavi and his like, it influenced all other constructive cultures around the world, and any literary school of thought today recognizes Mowlavi as one of its constituents

.However, other ordinary cultures do not enjoy such systematic establishment

Let us take the statement “Literary and artistic modernity inhibits scientific advances”<sup>(۱)</sup> into more careful consideration. By comparing it with the article !?.. “Scientific Bankruptcy Announced”,<sup>(۲)</sup> what may we conclude

On the other hand, had the need for organizing and saturating all of man's psychic aspects been taken into consideration while constructing and continuing cultural changes, certainly no advance in one cultural affect would inhibit the others; in other words, literary and artistic modernism would not prevent science from developing and inappropriate expectations of observation, experience, or ignorance towards ideological culture and scientific bankruptcy would never happen

:As we have already stated

The culture established by Islam is an aimed life that strongly activates human“ aspects of aesthetism, desire for knowledge, logic and idealism, and organizes all ”cultural elements

Artistic constructions in Spain, India, Iran and Syria – about the highly exquisite qualities of which all scholars on art agree –depict how strongly Islam enhances aesthetic aspects

:The Koran has pointed out God-made beauty on seven occasions, for instance

﴿We have adorned the lower heaven with the adornment of the stars.﴾<sup>(۳)</sup>

﴿We have set in heaven constellations, adorned them out to beholders.﴾<sup>(۴)</sup>

Say: Who has forbidden the ornament of God which he brought forth for His"

In the above verses, "ornament" and "adorning" refer to beauty, both in its general and special meanings. The first two verses show its special meaning, and the third refers generally to any attractive, useful phenomenon

encouraging thought had such a profound mental effect on Muslims that very soon Islam became the focal point of science and knowledge. During the dark Medieval era, when all countries were deprived of any knowledge, Muslims successfully kept the flame of science burning. Other cultural elements, such as moral ethics and idealism, also highly flourished. All of these organized advances were due to their being based on the original principle of the objectiveness of life. If the basis is destroyed, all effects arising in the name of culture will also be of compulsory origin, showing fake liveliness like a water-sprinkled flower cut from its stem

### **?Can a Society Have Various Cultures**

Before we answer this question, we must determine what is meant by "various" cultures. Let us consider some different kinds of culture

First: cultures able to coexist in harmony due to their original commonalities, e.g. the cultures of holy religions (Islam, the Jews, Christianity, Zoroastrianism, and any other religion able to verify its holy origin

The best reason for the potential for harmony among the above-mentioned cultures is the vast amount of various vital qualities that have made all divine religions ever since Abraham (a), uniting people from many religious bases

We clearly see how Islam, by providing freedom of belief and culture for the religiously intellectual, made harmony possible between them and Muslims, and all were able to endeavour in fields of science, ideology, industry, and culture throughout various eras of history; it seems the Islamic civilization has belonged to them all

Can history

ever deny the intimate, sincere co-operations various religions have made in medicine, in hospitals and research centres around the world since many years ago?

The real commonalities between various religions causing their harmony are original realities such as

1. (The source of the universe (God

2. (by giving them God's wisdom and will in order to emancipate and perfect man ;(logical thought, conscience, and great prophets

3. ;the realness of eternity

4. ;the fact that God Almighty is truly the greatest and wisest

5. all divine religions agree on the fact that man deserves a meritorious life, and is definitely entitled to dignity, graciousness, chastity, responsible freedom, education in all spiritual and/or physical matters

Of course, all religions agree on the basic rights in Abraham's religion; therefore, they should also be in agreement on any cultural element based on these rights

Second: cultures harmoniously common in fundamental ideologies and basics of natural life, and also cultures having the same ideas about the optimum, logical life – though their common points may not be religious

Examples are celebrations after victory over a common enemy threatening all people's lives; also, commonalities in creating arts that depict man-made advances towards a better life in this world

Third: cultures that conflict in their ideas and concepts of the universe, particularly in their interpretation of life and its primary end

Even if such cultures do not neutralize each other, obviously their differences would in time make them all 'colourless' cultures in coexistence; however, since their 'colourlessness' is due

.to disturbing conflicts, they would never be capable of harmony

There are numerous examples of these cultures, like the contrast between Iran's national culture and its religious culture –Islam Of course, their 'contrast' does not imply that they cannot harmoniously coexist; contrarily, as we see, the elements of national culture based on the real issues of physical and spiritual life –that can play a useful role to mentally prepare people to accept factors leading to prosperity, are also accepted in the religious culture, like artistic poetry which is a highly popular art in .Iran

Provided being applied in accordance with facts serving man's prosperity, this cultural element is not only undoubtedly accepted by Islam, but even strongly encouraged by some religious references to be used to develop descriptions of realities about the .world and man as they should be

The criterion for cultural harmony lies in those affairs useful for man's physical and

spiritual life. Such high cooperation and harmony between national and religious cultures caused Iranians to begin the greatest of scientific, philosophical, artistic, industrial, legal and moral services in the framework of Islamic culture, thus raising Iran to its pinnacle of flourish. Let us now briefly address national, religious and western cultures and their compatibility with Iranian culture

Those who claim Iran is capable of having three different cultures, should first consider the fact that, when added to a land, 'nation' is not just a word anymore; Iran's history goes way back in time, and our country has

seen various cultures in different eras. These scholars should be asked, therefore, which one of Iran's culture they mean

Iranian culture has gone through various periods; the Arian invasion; the Medes era; the Achmanid era; the Arsacides; the Parthians; the Keyan dynasty; the Sasanids; and many other ears after the rise of Islam. Are the commonalities among all of these eras meant here?

### **?Is Islamic Culture Compatible with Western Culture**

If by "culture" here we refer to phenomena making man's logical mode of life understanding, objective and mentally enlightening, it is not only certainly compatible with Islamic culture, but also even encouraged and promoted by it. The criterion is, however, whether Western culture is capable of basing itself upon an objective man in an objective world or not

During the last decade of the twentieth century, hedonism and utilitarianism dominated man's life goals in the West. Of course, we do not mean to deny the unquestionable figures and goodwill intentions occurring in Western countries. But the dominant trends are, as we mentioned above, mixed with various forms of opportunist authoritarianism

In brief, Islamic culture is based upon a "logical mode of life", which originates from

the commonalities among divine religions (actually, all from Abraham's religion); undoubtedly, any culture –Western or Eastern –able to adjust itself to these common basics can have a profound role alongside Islamic cultures in reviving the prosperity of human societies

Therefore, those who opine on the possibility of three harmonious cultures (national, religious and Western) coexisting in Iran, are either not thoroughly aware

Now let us consider the basics of today's culture in the West, and see whether they are acceptable in Islamic culture or not

First, we should keep in mind that the fundamentals of Western culture do not account for all of its people's thoughts and interest –the definitions given in dictionaries and encyclopaedias verify this, too –and are merely facts consisting of the foundation of their culture, or may be imposed by authoritative force

Therefore, persons or phenomena exist in their life-styles which contradict the basics of their culture. A few of today's fundamentals of Western culture are

Worldly life: man's “last” stop. Stated in most Western works, it makes up for the majority of Western scientific culture. Unfortunately, the authoritative power of science –sometimes even more forceful and inhuman than Medieval infidelity –is at times used for verifying this basic of their culture; scientific appearance, obviously, is sometimes much more harmful than scientific outcomes

Thus, with all of the evidence given by human conscience and pure logic that the world cannot be the end of man, relying on science in order to deny this fact will not

.only make science seem worthless, but even stupefying

Absolute freedom for any individual or group, provided that they do not disturb . ʁ  
others' legal rights Thus, individuals must have no legal confinement in life at all; one  
.can commit the filthiest of actions, and nobody can stop him/her

Let us remind

those who “expertly” tend to mix Western culture with Islamic culture about  
:quotations made by the US Attorney of State

For an American, law and religion cannot conflict more. Western countries, even"  
those that do not insist on the boundary between religion and politics, consider the  
law as just a worldly issue highly influenced by current affairs....which legislators and  
law courts are to carry out. The government should control it totally, not churches or  
religion. Thus, the law we have in America cleverly by-passes religion, and only  
breezes past moral dutifulness. In other words, an American can be law-abiding and  
(still morally deteriorated.” (١)

Can a culture only considering man's coexistence and legal rights towards other  
people ever be compatible with a culture that takes account of all human aspects,  
?guiding them in a law-supported “logical” path

The essence of power: although the essence of -power is generally not a main . ʁ  
component of Western culture -it is even still rejected in some Western literary and  
more works -but alas, its influence shows in every aspect of today's political and  
social culture in the West -particularly the practical aspects. Even cooperation,  
teamwork, appreciation for one's peers and their decisions is considered a device for  
achieving power; thus, the current trend in Western culture is not “Death is the  
natural destination for the weak; no powerful dies before weakening”, but the strong  
trying hard to weaken people in their own physical aspects, leaving them to struggle  
!towards their “natural destination”: death

The essence of pleasure: Not only does Western culture encourages pleasure in life, it even uses scientific jargon to justify it: “Depriving oneself of pleasures leads to complexes and other psychological abnormalities”

Although these passionate lovers of fame admit that leaving pleasures causes mental activities to weaken

they did not expand the concept to the pleasures of science, mystic knowledge, helping others, justice and piety

The essence of profit-making and opportunism: Utilitarianism is so obviously established in the West that there seems no need to prove its dominance through reasoning, explanations and surveys. This part of Western culture claims man to be constantly seeking his own benefits: “No one can stop me from achieving what is to my advantage; I am entitled to take as my own anything I consider advantageous to me, even though it may harm others.” Is this correct, or had we not better say, “Nobody has the right to harm or damage what I have

From logical, moral, legal, philosophical and religious points of view, definitely the latter is correct. It is totally immoral to let people appropriate anything they consider to their advantage! This can be claimed only when all people have the right to deflect harm coming to

Machiavellian trends in political culture: This method weakens all human rules and principles to the benefit of politicians' goals – who are definitely unaware of man's various needs thus making everything unimportant in their viewpoint

It is true to state that ever since Machiavellian methods stepped into human management, the essence and formality of mankind has suffered irrevocably We shall address another point on this matter in the next item

Spreading pragmatism without correctly interpreting it: If it were interpreted so that it claimed abstract, unreal concepts useless and inapplicable for find out the truth about the universe – since they are neither receivable nor practically usable – we could regard it as logical and acceptable, but the actual case is, the only criterion used to judge issues is clearly observable, outer actions

However, man's critical mental, spiritual and physical needs cannot be considered as acts; hope, goodwill, recognition of observable, logical beauty, justice and spiritual persistence and dutifulness are highly superior to utilitarianism and are the highest ideals and pillars of morality of most great religions', for they pertain to man's spiritual grandeur

When a culture considers the observable actions as the criterion, it has in fact ignored the most fundamentally important element of evolution: man's spiritual development

Limiting scientific knowledge: Limiting knowledge to what can be observed merely by physical senses and human-made laboratories, confines the primary factor in man's development –religion, morals, wisdom, mystic knowledge and other originally mental realities of

man's soul, the omission of which led to “The Bankruptcy of Science”, and human survival in the ۲۱st century was put into great danger.

Presenting irrelevant issues in the name of philosophy and ideology: It is an undeniable fact that for many years, not only has the West failed to come up with an

organized, systematic philosophical ideology, but even ignored the need to define some deeply meaningful concepts. Man, on the other hand cannot freely interpret and explain life without understanding the general basics of the four connections (man-himself, man-God, man-the universe, and man-other people

Prosaic arts: It is quite surprising how “arts” can be combined with the “prosaic”, which refers to anything low and destroying high human morals. The prosaic, referring to all of the immoral, cannot exist alongside art, which arises out of perfection

On the other hand, any prosy, root-drying, meaningless phenomenon can be presented to the unaware in a highly attractive form, and still cause the same amount of amazement. But can such spectacles reveal any of the realities concerning man's objective path of life? What kind of persons will the outcomes of these kinds of art be? Neither these arts, not their creators have able to answer such questions so far

As a whole, cultural triteness and employing culture to serve physical desires

### **Moral Corruption is the Main Reason for the Deterioration of Western Culture**

Let us now quote from Mr. Robert G. Ringer's statements, which are of the most alerting cries of the human soul in Western societies –drowning in mechanized

infidelity, insensibility due to superficial, limited desires – depicting the fall of original,  
:human cultures

What has caused the conditions of life in the West to change so much? Why have all“  
?of the good qualities vanished

In my opinion, the answer lies in the cleverly– laid conditions of ‘Abiding by Gradually–  
Imposed principles'. A highly effective technique, abiding by gradually– imposed  
principles becomes even stronger when man has some dependencies. Let us go into  
greater detail. Studies have shown that man does not respond positively to sudden  
.changes; in fact, he goes into defence and puts up a strong resistance

However, there is also much evidence that shows man cannot resist gradual changes,  
a fact well– understood by the enemies of individual liberty. They are clever enough to  
realize that they must act patiently. History clearly shows than that the world cannot  
be changed in two weeks. However, by moving step by step towards their goals, no  
one would ever notice their evil plans infiltrate people's lives. Thus, people give in to  
.gradual changes, considering it their destiny

Some generations may consider a particular lifestyle as slavery, whereas other  
generations may think of it

as freedom, for each generation knows only its own lifestyle. Thus, the deterioration  
of Western societies is the strongest evidence for the influence of these gradually  
.imposing methods

People have grown accustomed to the crisis around them; they have accepted the  
decadence, corruption and chaos that fill their surroundings. Only hope keeps them  
going; all they think of is when the demise may happen. Few people, however, believe  
.it would ever take place, for such falls are mostly based on momentary actions

The demise of the West fills quite a fluctuating diagram. America has deteriorated  
much faster during the years ۱۹۱۳ to ۱۹۶۳ than the previous ۱۳۷ years. Among those

fifty years, the last two decades prove to be more intense. However, there is no concrete evidence that deterioration accelerates every year, or that the Western civilization is nearing its demise; but it is definite that the present conditions will not be able to carry on easily

Although man has always faced problems, we now have many more problems than our predecessors, anyone over thirty years of age –by just looking carefully around him –will definitely agree on this. Unfortunately, however, most people do not even want to realize the danger threatening them. Their way of reasoning is quite amazing. They believe that if one neglects the problems and dangers (‘whatever will be, will be’), everything will look normal to him; his worries will fade away.”(1)

Mr. Ringer thus accounts for the rise of human rights at the time

:morals are disappearing in the West

When all moral ethics in the West were about to fall, Human Rights arose like a "sacred belief– or, better said; a major law (or right) –and gradually turned into a strong bond of unity among people. Whatever we name it –republic, mass, population ...is irrelevant! In a democracy, human rights mean safeguarding the borders of the country, which is the best way to satisfy the people. But the crucially important point is, many consider it in its lowest meaning: violating others' rights in the name of the 'majority's rights'; in other words, the stronger is always right! Such concepts are obviously in no way compatible with justice or morality.(1)

:When asked, “Is it too late?” Mr. Ringer says

I am frequently asked whether it is too late to save Western civilization or not. I believe the question is incomplete. Keep in mind that moral revolution has come to an end, for those social laws giving the rights and authority to desires –based on the idea

that 'Man is Entitled to His Desires' thus making chaos a sacred law –have reached their peak. So the more appropriate question will be: Can we rediscover and recover our former moral qualities? Can we ever make those moral values again the base of our civilization

If we can, there should be no worry whether it may be too late; there is no reason to believe we are incapable of providing people in the West with a

new life. In my opinion, the only hope is to rediscover Western civilization by means of correct moral values. Therefore, we should be brave, wise, and consciously try to find what destroyed these moral values, and then rebuild them.

Mr. Ringer should keep only one thing in mind: If he used “human civilization” instead of “Western civilization”, both the East and the West could be saved; ignoring the East and solely focusing on the West would prove aimless, for the two are strongly related.

?Is only considering the West not racist favouritism

This, indeed, is the destructive factor which originates from selfishness, and is the root of all problems in our times –especially in the West

Now let us consider the views of the renowned scholar, Erich Fromm, on the effect of cultural deterioration on the humanities in particular

.”Man is the only being that kills its kind without any biological reason“

Modern psychology is quite lifeless, for it easily cuts a human into different parts, ignoring a whole, living human being. In other words, it considers man as a set of certain qualities put together –like a machine –and totally overlooks him as being alive

Nowadays, man is considered as a tool still without a machine to be used in. A“

complete human sees himself / herself as an active piece of goods (in other words, an independent item of merchandise); hence, he is lonely and miserable. However, he ,tries to save himself from his misery. He is searching for happiness

In today's societies, man has become a zero, a part of a machine; as long as a“ society sees profit-making and production as man's highest end, this is inevitable. I believe today's social establishment has destructive roots, for it produces tendencies for destruction. The greater the tendency for destruction, the more miserable man (will be, and in turn less positive towards life.”(

### **Factors Stabilizing Cultures throughout History**

Some cultures or cultural elements certainly seem more stable than others. Various theories have been proposed accounting for their stability, and it is quite useful to study them. First, we should keep in mind that some cultures have not at all remained firm due to their elements being general human virtual facts –in fact, they should be ”.regarded as man's virtual elements “as they are

Studying these cultures may make their scholars and followers put serious effort into finding the natural reason brought about by their geographical, economic, social, political and historic aspect; thus, through realistic assessment of their cultures, they .may refine and advance human ideals and come to dynamic, objective cultures

For instance, slavery was a culture that even great scholars like Aristotle approved of; although it covered all human qualities in its own framework of slavery, it was still a totally incorrect culture that dominated most ancient lands. However, this culture cunningly rules out one of the most vital virtues of man –responsible freedom –thus upsetting man's developed thoughts into a

state of confusion and disorder. Islam, on the other hand, considered slavery a phenomenon totally irrelevant to man's "actual" virtues, and set out to demolish it

Thus, the reason for the stability and deep influence of a culture cannot abstractly lie in its human virtual reality. In order to recognize if a culture is truly useful and stable, therefore, we need not the period of time of its duration, but its basic factors. A few of the basic factors that stabilize cultures are

Factor One: the positive relationship between a culture – or some of its components – and the needs or luxuries of the members of a society. For example, the unique culture concerning living beings in India is based on regional factors or beliefs about living this only see in that area; likewise, the traditions of Nourooz (the new year celebrations) in Iran are due to Iran's climate, and have been established for many years

Factor Two: is time; the more aged cultural elements become, the higher their value will be. It is impossible to account for this factor, but we can say that firmness during a long time can be sign of stability in cultural elements; however, it is not enough to prove it. Selfishness has existed throughout the whole history of mankind; very few cases can be found in which man has succeeded in keeping his virtues aligned with true logic and used them correctly –the majority have fallen astray in assessing "themselves", and instead of having

the proper "self" (safeguarding their innate virtues up to perfection), they fall into ill-mannered selfishness. Such examples bring us to the conclusion that the stability of a culture in human lives does not necessarily imply its righteousness, although anything advantageous to man can prove original, and will remain firm for a long time



Factor Three: the formation of the culture of traditions, customs and beliefs plays a crucial role in giving a society a special nationality, and causes the people to be focused and organized. Soon these cultural elements will turn into the identity of the society, which it will defend to the last breath; of course, this is due to the fact that as time goes by, there is more communication among cultures, which in turn enhances .cultural studies and research, and modifications would prove necessary

Factor Four: the compatibility of cultures with facts and realities is verifiable. The stronger and deeper their compatibility, the better the stability of the cultural .elements

Apart from the second factor –which considers cultural stability as due to time and duration –the other above-mentioned factors do not do so. In case of the first factor, the reasons and necessities leading to the beliefs of the society require concern, if they are based on the psychological rules of the peoples; time will undoubtedly be unable to influence it. And if it depends on the personal beliefs of the intellectual .figures in the society, two factors will determine its survival

a. the qualitative and quantitative

;influence of the outstanding figures in the society

b. their qualitative and quantitative background logically supporting their culture's .stability

If the supporting factor is their cultural crystallization –directing the people as a truly original establishment –the culture will be deeply engraved in people's souls, and can strongly unite them. This is why time will not be able to influence it, for it enjoys logical .(backing.(.)

### **Blind Imitation of Past Beliefs and Cultures Inhibits Logical Thought and Wisdom**

We have already accepted that the firm establishment of culture among people does

not necessarily imply that it enjoys originality or is compatible with reality. Although a culture well-engraved in people's lives and souls does become a viewpoint to man and the world, many cultures past and present lose all of their composure when it comes to logical analysis; therefore man must analysis the dominant culture of his society and eliminate any sedimentary, baseless elements in it if he wants to take positive steps towards "elevating evolutionary life." But alas, sometimes imitation dominates great minds so much that all of man's thoughts are blocked. It seems we :deny the fact that

?How can an imitator also be a researcher? How can a wise one be the same as a fool Centuries come and go, but society leaders still do not understand how destructively inhibiting imitation is. first change from "person" to "thing" -in other words, from "researcher" to "imitator" - before they can change people, take advantage of them, and imprison them in a cage ?of illogical imitation

In brief, depriving people of sin, recognizing true life and its rules is a greatly .unforgivable and deserves no less than being banned from God's kind blessings

Blindly following the beliefs and traditions of the predecessors ruins one's mind; likewise following those drowning in their animal desires, those who have totally put

aside human morals or dignity in the name of freedom, modernity, progress, culture and so on, using such deceiving jargon to destroy all logic, consciousness or conscience

This is not an Eastern theory or religious prejudice, for we can see even more intense reflection, of such hatred for Western leader, by Western scholar, themselves in an interview with Spiegel, one of them had said, "Shame is fading away, and the urge to kill no longer know, any bounds. The mass media -television and radio stations the most have brazenly begun to use force and impudence in order to attract more customers for the general industry

Cultural critics are complaining about inadvertent violence, and have announced a moral disaster condition Sociologists, psychologists and politicians are angry with the sexual corruption presented in all cultural area, -TV and the film industry in particular. The confusion caused by insolence and violation is so great that even the Liberal Church of the Bible cries out about it in its publications

Duerr: They are definitely related. For instance, physical shame means limiting the  
.signs of sexual behaviour in order to keep a personal relationship chaste

.sexual attraction is meaningless

.Spiegel: But this freedom is highly publicized, contrary to your theory

Duerr: There certainly has been no society yet in which personal relationships are really so intensely publicized. This behaviour has also led to violence. It seems to be unprecedented throughout history.

.Spiegel: Freud spoke of a lack of shame that weakens the wisdom of mind

Duerr: That is true; there comes a time when man realizes that his own incompetence has led to a great lack of culture and civilization. Progress-orientated theorists have always claimed that primitive societies enjoyed much more zeal, endeavour, desire (and uncontrollable instincts that we do in our well-established society today.”

It is needless to mention how strongly Islamic culture and other divine religions have repeatedly warned man about the role of lust and undisciplined life in weakening thoughts.

Cultural adoption has become quite popular these days. As religion–opposed, immoral activities and phenomena are infiltrating religious societies,<sup>(1)</sup> the nobly dignified ones

.perfectionist potential would seek it under any circumstances

The most evident example possible for this is the Muslims' fantastic endeavours throughout the 7th through 15th centuries (Hijra) which innately aimed to establish culture, civilization and adopt the meritorious, suitable aspects from other countries. From the Caspian shores to the Atlantic waters, they prevented their original, evolutionary culture from demise. Such pioneers of culture and civilization indeed discarded any filthy, immoral phenomena that opposed religion in the name of culture, and only considered those realities which were advantageous to man's physical and spiritual life as culture

Two: Adopting dynamic, objective (evolutionary) cultures, although quite vital, does not mean imitation without studying, examining and refining

If they were told that such issues lack a soundly scientific basis and are merely subjective deductions or assumptions, they would abruptly disagree, "No! you are decadent! You are opposing science! The time

### **Culture Transfer**

Culture transfer is best in its useful, productive form, which includes realities . ۱ concerning meritorious methods for man's 'reasonable life.' Such cultural elements – like science, industries, religious qualities and elements based only upon man's pure



virtues – are not only suitable enough for everyone to cooperate in their transfer, but also Islam has considered it a religious duty

:Many Islamic references have emphasized on such cooperation. The Holy Koran says

Help one another to piety and good fearing; do not help each other to sin and enmity.“  
There is no piety or good deed in this world higher than spreading elevating cultures that can save man from ignorance, poverty, anxiety, and various needs. And fear God, [\(for surely he is terrible in retribution\)](#)

For instance, a) when the essence of sexual instincts and their priority over all other – ١ aspects had become popular in the past, some people in the East presented it as a scientific rule. After a while, a few psychologists like Adler and Jung discarded the theory. The writer has even heard from the late scholar Dr. Mirsepasi –who was a close friend of Freud –that his theory was more like a force, rather than a scientific issue. Later, some psychological experts claimed that the essence of safeguarding one's virtues and personality was the deepest, most active of the instincts, and took Freud's theory under more intense criticism. However, some of our academic institutions still consider it a scientific issue! Such mental deviation is a result of copying scientific culture, which destroys all truth-seeking spirits in man. b) As we all know, the theory of animal evolution to higher species was proposed by Lamarck and Darwin in the 19th century. Their accounts were no more than a novel theory. However, it infiltrated our society like a scientific law of concrete proof. But as time went by and more research was made, it was shown to lack evidence, and soon fell into dark obscurity. For further study, please see Pierre Rosseau, The History of Industry and Inventions

”are the most favoured by God

There remains no doubt that only life-saving cultures are the most vital and the most advantageous to man

In all major references on history and civilization – written whether by Western or Eastern researchers –it is agreed that when Muslims were free of their selfish, tyrant rules during the ۳rd through ۵th centuries (Hijra), they had the chance to adopt cultural elements from other nations of that time, expand their culture and civilization, and pass on their own useful cultural elements alongside the elements adopted, adjusted and refined; some historians have stated this era as being crucial to the protection of science and culture in the Medieval times

Transferring useful cultural elements, in order to gain economic or political advantages. In other words, the society intends to spread useful cultural elements to other societies in order to profit economically politically, or even dominate them; the purpose is not to follow ideal human goals or expanding helpful cultures. In these cases, the communities or nations conceding the cultures must take into careful consideration what they are adopting; otherwise, they would end up with a load of nonsense called ‘culture’, which would eventually ruin them

Transferring spiritually or physically corruptive and harmful factors to others in the .۴  
name of culture may possibly be the most vexed of human actions towards their  
peers. Creating and presenting sexually arousing devices on a large scale –though  
seemingly scientifically-based phenomena or depicting beauty – actually aims to  
.destroy mankind

The production of stories, paintings or other forms of ‘art’ implying nihilistic goals, .۵  
.however exquisite they may be, is equal to destroying human beings

Creating any works of art –no matter how attractive or fascinating –that humiliates .۶  
.and ridicules human character is equal to murder

Efforts towards establishing ignorance about social problems and neglecting the .۷  
.poor; cultural affects clearly show this

Any efforts towards depriving people of their responsible freedom grace, dignity .۸  
and the life they deserve is equivalent to destroying their souls, no matter what or  
.how the cultural activities may be

Any seemingly-cultural efforts .۹

Apparently, the expansion of cultural exchange is preparing the grounds for a global culture, and the differences among various peoples fading away. Some fear that this trend will cause man to be deprived of his long-established traditions. Others believe that the development of global cultures would lead to more variety and enrich [cultures all around the world.”](#)

First: Science and technology have been separated from culture; this is quite considerable, since they naturally provide a purely scientific viewpoint, and establish a profit-orientated basis. The meritorious aspects of science and technology have unfortunately been contaminated by profiteering trends

Second: Advances in culture development and exchange devices are highly crucial and unprecedented. If the cultural relationships and exchanges are not carefully calculated, social problems are very likely, for what is nowadays induced into people's minds as culture is not always originated from purely human emotions. If a general law –like the Human Rights –were written so that not only the study, adjustment and refining of cultures for being put into use for man's evolution, but also preventing filthy, commonplace phenomena entering other societies in the name of culture could be taken care of, original, dignified human cultures would find much more

other hand, original, productive cultures which take account of man's highest emotions and spirits have fallen way behind technology and its characteristics nowadays. Let us return to Professor Bahanan's article, where he clearly elaborates on this fact

Some sociologists believe most social problems are due to the fact that some cultural" elements progress more slowly than others. Most retardation in the history of the United States have been in non-physical aspects, e.g. thoughts and traditions. Science and technology advance at such great speed that they leave non-physical cultural "issues way behind

### How Cultural Aspects Can Be Transferred from One Society to Another

”Seek knowledge even if it may mean going all the way to China”

It was due to this belief that Muslims made great efforts ever since the rise of Islam towards acquiring the perfect cultural elements of other nations, and not only did they discover plenty of cultural and ideological realities about other cultures during the 7<sup>th</sup> and 8<sup>th</sup> centuries (Hijra), but also fertilized them and got quite significant results with highly elevated their findings

Thus, Islam not only never prevents adopting positive foreign cultural elements –the most apparent example to name of is science, a means of achieving the truth –but even strongly recommends it. Islam, therefore, accepts any cultural elements that can effectively discover or adopt true facts

It is of great importance that anthropologists distinguish real scientific issues –which are proved through concrete scientific evidence –from potentially right or wrong theories and deductions; in other words, although such theories aim to account for certain phenomena, they have not yet been definitely approved of. Studying them in anthropological fields as the mere theories or deductions

The current Western knowledge of the nature of man has led to a vast amount of anthropological explanations, concepts and issues so popular that they have become the source of many interpretations about various human aspects, e.g. ‘strong tendencies towards essential pleasures and enjoyment,’ which following Freud's approval, began to look like a matter of scientific significance

Apart from a very few number of wise, truth-seeking ones, most people in the West account for human issues on the basis of the highly popular hedonistic viewpoints. It is

the unquestionable duty of a developing, perfectionist society to carefully seek reasons for all human aspects, and to take into serious consideration the fact whether man is naturally hedonistically orientated or not, and if he is, are the pleasures  
?concerned with only natural, purely physical ones

Should spiritual, mental pleasures not be included? Is a society where no pleasures are based on the pains and inconveniences of others possible? In fact, such people have –using mental, social, regional and political factors –put so much emphasis on a human aspect that does not even innately exist in him that it now seems to be an essential part of human nature in the eyes of the simple-minded. Thus the establishment of Western culture nowadays is not comprehensible without taking  
(hedonistic principles into consideration.)

For further elaboration on this point, we must mention a highly dramatic change – ۱ that has occurred nowadays, and the results it has brought about: When the West broke down all walls confining freedom and its glorious values, liberty –a vital phenomenon which is the best path to perfect virtues– turned into an undisciplined beloved which became so popular that it had the last two centuries named after it (actually, of course, named after immorality). It had better be called the century of ‘self- strangeness.’ Is this not a cause-and-effect outcome? Indeed, for unlimited freedom first victimizes human character. It became so sacredly worshipped that even philosophers and humanity scholars glorified undisciplined freedom to the very highest aim of life. Books like About Freedom by John Stuart Mill are examples of such infatuation. Due to a small mistake between the end and the means, anyone – even the least educated –spurred by internal desires or limited knowledge, took the advantage of the necessity of freedom of speech, and expressed such exclusive, definite opinions as if they were the sole creator, of man, and possessed every knowledge or experience in creation! The opinions were as greatly numerous as their so-called scholars. They were only whimsical brainwaves of philosophy and



anthropology majors. On the other hand, they never thought about who should accept their ideas. Is everyone intelligent enough like Avicenna, Razi, Abu-Rehyan Biruni, Mowlavi, Bacon, Descarte, Kant or Hegel to be able to correctly evaluate such opinions? Or are most of them simple people who are prone to drown in the swamp of wrong ideas. Still, contradicting theories poured in the field of anthropology and human knowledge, which made all existing ideas doubted, and people lost most of their interest in such researches. Some conscientious scholars could have suggested that in order to save man from such anthropological vertigo, all theories must first be analyzed alongside other fields and issues, and discussed with sincerely serious anthropologists in order to achieve a final, combined fact; when the theory showed reality, it can be publicly presented. Even if someone in the West has come up with this suggestion - which we have not heard anything about yet -it has unfortunately been overruled. All in all, having a society able to move towards the truth in complete independence is crucially necessary

elements originate from ethical and regional features exclusive to some nations or peoples, and thus lack a universally human quality like taboo behaviours of tribal customs and particular interpretations of minor aspects of life. According to Islam's definition of culture (as an objective, creative culture), such elements are not only definitely unusable in anthropological issues, but even cannot be considered as ideal cultural phenomena

There are other cultural elements that are compatible with reasonable human ideals. For instance, by studying religious cultures in various nations, we find that some cultural elements maybe considered unimportant in others -or maybe even illogical. A logical reasoning brings us to the conclusion that all of them originate from an extremely reasonable human ideal which has been degraded through time to a worthless phenomenon due to regional points of view and mental manipulations. We face such phenomena in various forms of worship for God. The Koran has also [\(pointed it out.\)](#)

One of the commonest of human ideals that is degraded to lowly phenomena is justice -which, in its general form, is universally approved of. Since law has existed

throughout the history of man, there is no exception to the fact that justice is accepted by everyone; when law exists among fellow men, every aspect of their life either obeys the law or defies it. (Let us suppose the latter is the case.) If they obey the law, justice exists; if not, there will be cruelty and deviation. However, we know

Let us first mention again that the reason why man accepts culture is his intense tendency for perfection, which is undoubtedly mighty; individual and social advances  
.in various fields such as science and technology clearly prove it

Now we must see why perfection-seeking human accepts destructive, corrupt factors  
?so easily

The most important reason for corruption is the vacuum-like gap of the realities of evolutionary culture among the society. In such an abyss, man's innate desire for perfection will either fade away, or may remain. If the former is true, lust and animal desire will dominate man's internal existence, and make any kind of corruption seem like enjoyment or even a necessity, and become the highest aim of his life. In such cases, all fundamentals like religion, ethics, law, economics, and politics will be  
(manipulated by corruption, and lead the society for eventual demise.)

In the second case, if the innate desire for perfection still exists deep inside man, it can again be activated provided the necessary conditions, and attain original, positive

cultural elements once more. If society leaders can safeguard it against corruption in fields like religion, politics, law, morality and education, and provide the grounds for its activation, the gap will obviously be filled with original, evolutionary culture. In any case, therefore

## Deculturalization Instead of Cultural Generalization

Unfortunately, culture is falling apart instead of enhancing its common cultural elements during the late 20<sup>th</sup> century; the turning point

Mikhail Naima, the renowned contemporary Christian scholar thus describes Imam –۱ Ali (a) in his preface to George Gordac's Ali (a), *The Voice of Human Justice*: “The lives of great human beings overflow with experiences, lessons, faith and hope. They are high peaks that we are eagerly attracted to. As shining minarets, they light up the darkness along our way. They always remove any doubts about life, its aims and prosperity in us. We had better call it the ‘anti-culture’, or ‘deculturalization’ of human societies. It tends to deliver the final blow to humanity: first demolish human realities and fundamental values, destroy the sacred foundation called ‘family’, and eventually call .the whole earth a useless part of the solar system, and ruin it

May God save mankind once again from those who destroy human values and deculturalize humanity, and grant us deliverance by enhancing our logic, reason and [\(conscience.\)](#)

global culture' we do not refer to all elements and phenomena, for any society innately has certain characteristics in regard to religion, the universe and fellow men .that are exclusive to its own historical, geographical and social factors

What we mean by global culture are the general realities of culture, such as fundamental moral virtues (love for fellowmen, sacrificing for human ideals), accepting a worthy, meritorious life for mankind, accepting reasonable (responsible) .freedom for all, and accepting to try hard to advance man's highest goals

If the four above-mentioned fundamentals (global human economy, global human power, global human rights, and global human politics) are logically established, global culture is obviously achievable. We realize that all divine religions -originating from Abraham's -based upon man's pure, innate virtues (especially Islam, which covers all of their basics) would warmly accept such a culture. If all human societies do not .possess the four fundamentals, this culture will never be able to exist

The reason why is quite clear. Considering the definition for culture (the proper, worthy or meritorious qualities for man's physical or spiritual life phenomena or activities based on logic and emotions originating from reasonable life<sup>(1)</sup>),no society can enjoy a dynamic, objective evolutionary culture by means of an imperfect economy, lack of establishment for people's physical or spiritual enhancement or a

Azizi, the Caliph of Cairo, had a library containing ۱,۶۰۰,۰۰۰ books, ۶۵۰۰ volumes of which were on mathematics and ۱۸۰۰۰ others on philosophy. His son, as his successor, did a great deal to develop the library, and built ۱۸ study halls near it

In addition, governors and visitors throughout history have played a significant role in gathering books and constructing libraries that paved the path toward scientific advance. Mahlabi left after his death a library of ۱۷۰,۰۰۰ books. His young colleague, Saheb-ibn-Ibad, had collected ۲۰۶,۰۰۰ books, and one of Saheb's judges had collected over a hundred thousand books. These figures are, nevertheless, approximate. Many librarians were busy working in Cairo, where only two of the libraries had ۲,۲۰۰,۰۰۰ books. In ۸۹۱, there were a hundred libraries in Baghdad" (1
